

# Boating Access Program

## **Background**

The Maryland Department of Natural Resources (the Department) invites local jurisdictions who own or have long term irrevocable lease managing public boating facilities to participate in federal Sport Fish Restoration – Boating Access (BA) Program in order to provide access to and from the water for recreational, trailered, motorboats.

Approved projects receive up to 75% BA funding. The match (minimum 25%) must be provided by state, local, or a combination of state/local funding. Under the BA Program, the U.S. Fish and Wildlife Service (USFWS) is the “Grantor,” the Department is the “Grantee,” and the local jurisdiction is the “Sub-Grantee.” In other words, federal funding is passed through the Department to the local jurisdiction along with all the requirements of the Program.

## **Projects eligible for BA funding**

The BA Program funds various recreational boating access projects including but not limited to the design and construction of public boat ramps with the associated parking lots, access roads, bulkheads, breakwaters, and piers. Check out the detailed [eligible list](#).

In Maryland, due to the limited apportionment, the federal BA funds are primarily used for constructing and/or renovating public boat ramps, trailer parking areas, and other associated amenities. Even though many other activities are eligible for BA funding, the priority remains to fund the new construction or improvement of the **public boat ramps** for recreational trailered motorboats. The Department will determine which project is most appropriate for BA funding.

## **When and where to apply**

The BA Program is open year round.

## **What to expect**

- After a preliminary discussion to see if your project is a good fit, we will work with you on preparing the federal grant application package. The core of the

application package is a "Project Statement" that contains detailed information about the proposed project including a justification and scope of work.

- Once USFWS approves the grant, the Department and the local jurisdiction enter into both a Memorandum of Understanding (MOU), which establishes a mechanism for the Department to pass through the federal funds; and a Land Control Agreement (LCA), which basically ensures that the local jurisdiction will comply with all federal/state requirements during the construction of the project and for its "useful life" (typically 20 – 40 years as determined by a Professional Engineer).
- BA grants provide reimbursements for eligible expenses. **With the exception of approved pre-agreement costs, if any, no expense may be incurred and no expense is reimbursable until both the MOU and LCA are fully executed.**

Both the MOU and LCA are legally binding contracts and ALL items in the contracts are important. A few highlights are:

- 1) The local jurisdiction is responsible for obtaining all necessary permits.
- 2) The local jurisdiction must submit the project plans and specifications to the Department for review and approval.
- 3) The local jurisdiction must advertise the project for bid, submit the bid tabulations and the recommended award for the Department's approval before awarding the contract.
- 4) The facility must be reasonably available to the public (via physical access, equitable fees, and open periods). ADA accessibility guidelines must be applied and appropriate signage must be posted.
- 5) Any fees must be both approved by the Department and must not discriminate against any user. All users (including boaters from out-of-state) must be charged the same.
- 6) If a fee is charged, it must be kept in a separate account and used to offset the cost of operating and maintaining the facility.
- 7) The local jurisdiction must maintain the facility for the useful life of the project.
- 8) Activities that interfere with the purpose of the public boating access facility are prohibited.
- 9) If the local jurisdiction ceases to maintain the facility as described in the contract, the local jurisdiction must reimburse ALL federal/state dollars to the Department (with no proration).
