Applicant Information

- 1. Provide your full name as it appears on your commercial fishing license
- 2. Provide your mailing address
- 3. Provide your city, state, and zip code
- 4. Providing your email address is optional
- 5. Provide your daytime and cell phone numbers including the area code.

Eligibility

- 6. If you do not have a Maryland commercial fishing license then you are not qualified to apply for this permit (Code of Maryland COMAR <u>08.02.05.24</u>).
- 7. If you do not own a vessel then you are not qualified to apply for a spiny dogfish permit (COMAR 08.02.05.24). If you own a vessel and are selected to receive a state spiny dogfish permit, you will need to provide proof of ownership or share of ownership. Only one vessel owner can qualify for a permit. If there is more than one owner of a vessel, a licensee may declare the vessel on the spiny dogfish landing permit if the licensee: (i) owns at least 51 percent of the vessel; or (ii) has permission from the other owners who, whether individually or in combination, own at least 51 percent of the vessel.
 - a. Provide the name of the vessel that you are seeking to obtain a spiny dogfish permit on. If the vessel is not named, write "Not Named" in that field.
 - b. Provide the Maryland registration number or the federal documentation number.

Maryland Coastal Bays/Atlantic Ocean State Permits

This section is only applicable to Maryland state issued permits. Federal permits are not eligible for consideration.

- 8. If you own an Atlantic striped bass permit then please circle yes and answer sub-questions (a) and (b). Four points will be assigned for each permit per year held. Zero points will be awarded if you do not own an Atlantic striped bass permit. The point value for this permit is higher than others on this application because of the likelihood of interacting with spiny dogfish.
- 9. If you own a black sea bass permit then please circle yes and answer sub-question (a). Two points will be awarded for each year a black sea bass permit was held. Zero points will be awarded if you do not own a black sea bass permit.
- 10. If you own a horseshoe crab permit then please circle yes and answer sub-question (a). Two points will be awarded for each year a horseshoe crab permit was held. Zero points will be awarded if you do not own a horseshoe crab permit.
- 11. If you own a summer flounder permit then please circle yes and answer sub-question (a). Two points will be awarded for each year a summer flounder permit was held. Zero points will be awarded if you do not own a summer flounder permit.
- 12. If you previously held a spiny dogfish permit then please circle yes and answer sub-question (a). One point will be awarded for each year a spiny dogfish permit was held.
- 13. If you currently have a spiny dogfish permit, you will not be awarded any points. The point value is higher for new entrants to provide an opportunity for new people to enter the fishery.

14. Do you own a vessel with Maryland spiny dogfish landings? Landings will be confirmed with the Atlantic Coastal Cooperative Statistics Program (ACCSP) Data Warehouse. Answer sub-questions (a-c) if you have landings.
