Conditions of Dan's Mountain Pool Rental Agreement

- Payment is required at least two weeks in advance.
- Cancellations made prior to the date of the event are subject to a \$25 cancellation fee.
- No refunds will be given for cancellations made on the same date of the event unless the cancellation is the result of a pool closure.
- Pool closures are determined by the pool manager and may occur due to weather or other unsafe conditions.
- Pool rentals for commercial purposes are not permitted.
- All patrons must obey lifeguards and follow the pool rules, which include the following:
 - **No running on deck.**
 - **No diving in any depth less than 9 feet.**
 - **No alcohol.**
 - **No glass containers within the enclosed pool area.**
 - **No smoking within the enclosed pool area.**
 - No swimming without a lifeguard on duty or when the pool is closed.
 - Persons with open wounds, bandages, or rashes are not allowed in the pool.
 - No eating, drinking, or chewing gum while in the pool.
 - No flips, summersaults, or running starts into the pool.
 - No rough play, such as dunking, pushing, wrestling, or other unsafe acts.
 - No profanity or disorderly acts.
 - No pets within the enclosed pool area, except for service animals (which are allowed only on deck, not in the pool).
 - No fires or charcoal grills within the enclosed pool area.
 - No amplified music without prior approval from park management.
 - Appropriate swim attire is required.
 - Swim diapers or rubber pants are required for all infants and toddlers. No regular diapers.
 - Children under the age of 13 must be supervised by an adult at all times.
 - Waterslide users must be at least 3 feet tall.
 - A lifeguard may administer a swim test to evaluate a child's swimming ability prior to allowing use of the waterslide.
 - Non-swimmers must wear a PFD on the waterslide, and PFDs must be properly fitted and free of loose straps or other objects.
 - No running, standing, kneeling, rotating, tumbling, or stopping in the waterslide flume.
 - No diving from the waterslide flume.
 - Only one person at a time may enter the waterslide flume, and the landing area must be clear prior to entering the flume.
 - Waterslide users must enter feet first, and keep hands and feet inside the flume.
 - Waterslide users must leave the landing pool promptly after exiting from the flume.
 - No foreign objects are permitted on the slide, including toys, tubes, noodles, kickboards, swim arm floats, or other non-approved flotation devices.
 - Parents may not catch children at the bottom of the waterslide, as this can result in injury.
 - Additional rules may apply.
