## DESCRIPTION OF PERMITS

Spiny Dogfish Permit	Allows an individual with a FIN, HLI, or UTFL to harvest Spiny Dogfish for sale. See COMAR 08.02.05.24 for more information.
American Eel Permit	Allows an individual with a FIN, UTFL, LCC, or CB3 to harvest American Eels for sale. See COMAR 08.02.05.08 for more information.
Black Sea Bass Permit	Allows an individual with a FIN, HLI, or UTFL to harvest Black Sea Bass for sale. See COMAR 08.02.05.21 for more information.
Finfish Trotline Permit	Allows an individual with a FIN, UTFL, or Invasive Catfish Finfish Trotline License to harvest species for sale in certain tidal waters using a finfish trotline. See COMAR 08.02.25.06 for more information.
Horseshoe Crab Permit	Allows an individual with a FIN or UTFL to harvest Horseshoe Crabs for sale. See COMAR 08.02.10.01 for more information.
Jonah Crab Permit	Allows an individual with a LCC, CB3, CCTL, or UTFL to harvest Jonah Crab for sale. See COMAR 08.02.08.06 for more information.
Snapping Turtle Permit	Allows an individual with a CCTL or UTFL to harvest Snapping Turtles for sale. See COMAR 08.02.06.01 for more information.
Summer Flounder Permit	Allows an individual with a FIN, HLI, or UTFL to harvest Summer Flounder for sale. See COMAR 08.02.05.12 for more information.
Yellow Perch Permit	Allows an individual with a FIN, HLI, or UTFL to harvest Yellow Perch for sale. See COMAR 08.02.21.03 for more information.
