#### .03 Threatened, and Endangered [Species] Species, and Species in Need of Conservation.

#### A. [Definitions] Repealed.

- [(1) "Species in need of conservation" means those fish and wildlife whose continued existence as a part of the State's resources are in question and which may be designated by regulation by the Secretary of Natural Resources as in need of conservation pursuant to the requirements of Natural Resources Article, §§10-2A-03 and 4-2A-03, Annotated Code of Maryland.
- (2) "Threatened species" means any species of fish, wildlife, or plants designated as such by regulation by the Secretary of Natural Resources which appear likely, within the forseeable future, to become endangered, including any species of wildlife or plant determined to be a "threatened" species pursuant to the federal Endangered Species Act, 16 U.S.C. §1531 et seq., as amended.
- (3) "Endangered species" means any species of fish, wildlife, or plants which have been designated as such by regulation by the Secretary of Natural Resources. Designation occurs when the continued existence of these species as viable components of the State's resources are determined to be in jeopardy. This includes any species determined to be an "endangered" species pursuant to the federal Endangered Species Act, cited above] *Repealed*.
- B. Policy. In developing [their] *and updating its* Critical Area [programs, local jurisdictions] *program, a local jurisdiction* shall provide protection for [those] *threatened, and endangered species*, species in need of conservation [and threatened and endangered species], and their habitats [which occur] in the Critical Area.
- C. Criteria. In developing [their] *and updating its* Critical Area [programs, the local jurisdictions] *program, a local jurisdiction* shall use [all of] the following criteria [with regard to species in need of conservation and threatened or endangered species:
  - (1) Local jurisdictions shall develop programs for the protection]:
- (1) Protection of the habitats of threatened, and endangered species, and species in need of conservation [and threatened and endangered species. These programs should be developed using] in cooperation with the expertise of the [Forestry Programs, the Fish, Heritage and Wildlife Administration,] Department of Natural Resources and other appropriate public agencies and private organizations.
  - (2) These programs shall consist of at least one [or both] of the following elements:
- (a) *Designation* of a protection area around each of the habitats occurring in the jurisdiction within which development [activities] and other disturbances shall be [prohibited] *prohibited*, unless it can be shown that [these activities] *the development* or [disturbances] *disturbance* will not have or cause adverse impacts on these habitats; *or*
- (b) [Development of programs for providing protection for] *Protection of* the habitats of *threatened, and endangered species and* species in need of conservation [and endangered and threatened species which may include, but are not limited to,] *by means of* acquisition, conservation easements, cooperative agreements with landowners, special provisions in forest management and soil conservation plans, [and special provisions in subdivision or zoning regulations] *or other methods approved by the Commission*.
- [(3) The determination of the existence and extent of these habitats and protection areas shall result from a cooperative effort between the local jurisdiction and the public agencies or private organizations noted above, but no designation of habitat and protective measures shall be accomplished unless the affected public is given an adequate opportunity to be heard at the local level. A local jurisdiction's public hearing on its proposed Critical Area program may be used to satisfy this requirement, if full notice of the proposed habitat management program is included in the general notice of the hearing. If the Secretary of Natural Resources designates additional species by regulation in the future, additional local public hearings, as appropriate, shall be held to consider comments on the protection measures proposed for these species. The protection measures shall be adopted within 12 months of the date of the Secretary's designation.]

#### .04 Plant Habitat and Wildlife Habitat.

- [(1) "Plant habitat" means a community of plants commonly identifiable by the composition of its vegetation and its physiographic characteristics as described below in §C.

- (4) Protect [those] *plant and* wildlife [habitat types and plant communities] *habitats* which are determined [by local jurisdictions to be of local significance] *to be locally significant habitats*; and

- C. Criteria. In developing [their] *and updating its* Critical Area [programs, the local jurisdictions] *program, a local jurisdiction* shall [use all of the following criteria]:
- (1) [The local jurisdictions shall develop] *Include* a plant and wildlife habitat protection program as an element of [their] *its* Critical Area program. [These programs are to be] *Each program shall be* developed using the expertise of the [Forestry Programs, the Tidewater Administration, Fish, Heritage and Wildlife Administration] *Department of Natural Resources*, the U.S. Fish and Wildlife Service, other appropriate agencies, and adjacent jurisdictions.
- (2) [Each] *Ensure that each* plant and wildlife habitat protection program [shall consist] *consists* of [the following]:
  - (a) Identification of the following plant and wildlife habitats in the Critical Area:
    - (i) [Colonial] Nesting sites of colonial nesting water [bird nesting sites] birds;
- (ii) [Historic waterfowl] Waterfowl staging and concentration areas in tidal waters, tributary streams, or tidal and nontidal wetlands;
- (iii) Existing riparian forests [(for example, those], *such as* relatively mature forests of at least 300 feet in width which occur adjacent to streams, wetlands, or the [Bay] shoreline[, and which are documented breeding areas)] *of the Chesapeake Bay, the Atlantic Coastal Bays, or their tributaries*;
- (iv) [Forest areas] *Forests* utilized as breeding areas by forest interior dwelling birds and other wildlife species [(for example], *such* as relatively mature [forested areas] *forests* within the Critical Area of 100 acres or more, or forest connected with these [areas)] *breeding areas*;
- (v) Other areas which may in the future be identified by State and federal agencies as important plant or wildlife habitat [areas];
  - (vi) (text unchanged)
  - (vii) [Natural] Designated natural heritage areas [which have been designated].
- (b) [Establishment of programs for conserving or protecting] *Programs to conserve or protect* the plant and wildlife [habitat areas] *habitats* identified [above] in SC(2)(a) of this regulation. [These programs, and the protection measures suggested below, should accomplish the following objectives] *Program objectives should include*:
- (i) [Establish buffer areas for colonial water bird (heron, egret, tern and glossy ibis) nesting sites] *The establishment of buffers for nesting sites of colonial nesting water birds* so that these sites are protected from the adverse impacts of development [activities] and from disturbance during the breeding season.
- (ii) [Provide that] *The location of* new water-dependent facilities [are so located] *so* as to prevent disturbance to sites of significance to [wildlife] *wildlife*, such as [historic,] aquatic staging and concentration areas for waterfowl.
- (iii) [Provide protection measures] *Protection measures*, including a buffer [area] where appropriate, for other plant and wildlife [habitat sites] *habitats* identified in  $\SC(2)(a)(v)$  of this regulation.
- (iv) [Protect and conserve those forested areas] *Protection and conservation of forests* required to support wildlife species identified [above] in C(2)(a)(iii) and C(iv), C(iv) of this regulation by developing management programs which have as their [objective, conserving the] *objective the conservation of* wildlife that inhabit or use the areas. The programs should assure that development [activities,] or the clearing or cutting of trees [which might occur in the areas,] is conducted so as to conserve riparian [habitat,] *habitat and* forest interior [wildlife species,] *dwelling birds* and their habitat. Management measures may include incorporating appropriate wildlife protection elements into forest management plans, [and] cluster [zoning] *zoning*, or other site design criteria which provide for the conservation of *plant and* wildlife habitat. Measures may also include soil conservation plans that have *plant and*

wildlife habitat protection provisions appropriate to the areas [defined above,] *identified in*  $\S C(2)(a)(iii)$  and (iv) of this regulation and incentive programs which use the acquisition of easements and other similar techniques.

- (v) [Require, to the extent practical, that when development activities, or the cutting or clearing of trees, occurs in forested areas] When development or cutting or clearing of trees occurs in a forest, a requirement that, to the extent practicable, corridors of existing forest or woodland vegetation be maintained to provide effective connections [between] among wildlife [habitat areas] habitats.
- (vi) [Protect by appropriate means those] *The protection of* plant and wildlife habitats considered to be [of significance by local jurisdictions. (Examples of these areas are those whose habitat values may not be of Statewide significance but are of importance locally or regionally because they contain species uncommon or of limited occurrence in the jurisdiction, or because the species are found in unusually high concentrations.)] *locally significant habitats*.
- (vii) [Protect natural heritage areas] *The protection of a natural heritage area* from alteration [due to] *resulting from* development [activities] or cutting or clearing so that the structure and species composition of the [areas] *area* are maintained.
- (c) The determination of the existence and extent of [these] plant and wildlife [habitats,] *habitats* and the development of appropriate protection measures for these [areas,] *habitats* shall result from a cooperative effort [between the] *among a* local jurisdiction [and the], public agencies [or], *and* private organizations [noted above]. [Designation of habitat and protective measures may not be accomplished unless the affected public is given an adequate opportunity to be heard. A local jurisdiction's public hearing on its proposed Critical Area program may be used to satisfy this requirement, if full notice of the proposed habitat management program is included in the general notice of the hearing. If additional plant and wildlife habitat areas are designated in the future, local public hearings, as appropriate, shall be held to consider comments on the areas and protection measures proposed.]

### Subtitle 02 DEVELOPMENT IN THE CRITICAL AREA RESULTING FROM STATE AND LOCAL AGENCY PROGRAMS

#### Chapter 05 State Agency Actions Resulting in Development on State-Owned Lands

#### 17 .08 Surface Mining.

- A. Criteria. When surface mining occurs on State-owned lands, the agency administering these lands shall assure that the operations are conducted according to the following criteria:

- (3) Provide that future sand and gravel operations [do not occur] *are not located* in areas unsuitable for mining. [Areas unsuitable occur] *Unsuitable areas include locations* where:
- (a) Important natural resources [such as threatened and endangered species, areas of scientific value, or rare assemblages of species occur as discussed in] *are found, as covered in* Regulations [.09--.13] .11 and .12 of this chapter;
  - (b)—(d) (text unchanged)
  - (4)—(6) (text unchanged)

#### .11 Threatened, and Endangered Species [and], and Species in Need of Conservation.

- A. [Definitions] Repealed.
- [(1) "Species in need of conservation" means those fish and wildlife whose continued existence as a part of the State's resources are in question and which may be designated by regulation by the Secretary of Natural Resources as in need of conservation pursuant to the requirements of Natural Resources Article, §§10-2A-03 and 4-2A-03, Annotated Code of Maryland.
- (2) "Threatened species" are any species of fish, wildlife, or plants designated as such by regulation by the Secretary of Natural Resources which appear likely, within the foreseeable future, to become endangered, including any species of wildlife or plant determined to be a "threatened" species pursuant to the federal Endangered Species Act, 16 U.S.C. §1531 et seq., as amended.
- (3) "Endangered species" are any species of fish, wildlife, or plants which have been designated as such by regulation by the Secretary of Natural Resources. Designation occurs when the continued existence of these species as viable components of the State's resources are determined to be in jeopardy. This includes any species determined to be an "endangered" species pursuant to the federal Endangered Species Act, cited above] *Repealed*.
- B. Criteria. When planning or proposing development [or redevelopment] on State-owned lands within the Critical Area, the agency proposing the development shall [use the following criteria]:
- (1) [The agency shall identify, with] *With* the assistance of the Department of Natural Resources, *identify* any habitats of [threatened] *threatened*, or endangered species, or species in need of [conservation,] *conservation* that may be affected by the development;
- (2) [The agency shall develop] *Utilizing the expertise of the Department of Natural Resources, develop* programs [for the protection of] *to protect* the habitats of *threatened, and endangered species, and* species in need of

conservation [and threatened and endangered species] as [may be] identified in §B(1) of this regulation[. These programs should be developed using the expertise of the Maryland Department of Natural Resources]; and

- (3) [These programs shall consist of one or both] *Ensure that these programs consist* of *at least one of* the following elements:
- (a) Designation of a protection area around each of the habitats within which development [activities] and other disturbances [shall be prohibited] *are prohibited*, unless it can be shown that [these activities] the development or other disturbance will not have or cause adverse impacts on these [habitats,] habitats; and
- (b) [Development of programs for providing protection for] *Protection of* habitats of *threatened, and endangered species, and* species in need of conservation [and endangered and threatened species], which may include[, but are not limited to,] special provisions in forest management and soil conservation plans, and [special provisions in] any *other* management programs for the State-owned lands on which the habitats occur.

#### .12 Plant Habitat and Wildlife Habitat.

#### A. [Definitions] Repealed.

- [(1) "Plant habitat" means a community of plants commonly identifiable by the composition of its vegetation and its physiographic characteristics as provided in §B of this regulation.
- (2) "Wildlife habitat" means those plant communities and physiographic features that provide food, water and cover, nesting, and foraging or feeding conditions necessary to maintain populations of animals in the Critical Area as provided in §B, below] *Repealed*.
- B. Criteria. When planning or proposing development [or redevelopment] on State-owned lands within the Critical Area, the agency proposing the development shall [use the following criteria for plant and wildlife habitat]:
- (1) [The agency, with] *With* the assistance of the Department of Natural Resources, [shall] identify the following plant and wildlife habitats that may be affected by the development:
  - (a) [Colonial water bird nesting sites] Nesting sites of colonial nesting water birds;
- (b) [Historic waterfowl] *Waterfowl* staging and concentration areas in tidal waters, tributary streams, or tidal and nontidal wetlands;
- (c) Existing riparian forests [(for example, those], *such as* relatively mature forests of at least 300 feet in width which occur adjacent to streams, wetlands, or the [Bay] shoreline[, and which are documented breeding areas)] *of the Chesapeake Bay, the Atlantic Coastal Bays, or their tributaries*;
- (d) Forest areas utilized as breeding areas by forest interior dwelling birds and other wildlife species [(for example], *such* as relatively mature forested areas within the Critical Area of 100 acres or more, or forest connected with these [areas)] *areas*;
- (e) Other areas which may in the future be identified by State and federal agencies as important plant or wildlife habitat [areas]; and
  - (f) [Natural] Designated natural heritage areas [which have been designated].
