**Application for Shellfish Aquaculture Lease – Timothy M. Robinson, Sr. & Susan Robinson**  
**#587, Dorchester County**

The Secretary of Maryland Department of Natural Resources (DNR), pursuant to Natural Resources Article, §4-11A-09(g), Annotated Code of Maryland, is giving notice of an application for a shellfish aquaculture submerged land lease by Timothy M. Robinson, Sr. and Susan Robinson in Fishing Bay, Dorchester County, Maryland, located approximately 3,700 feet northeast of Fishing Point, off Elliott Island, and directly abutting another shellfish lease held by the applicants (DO715). The area applied for contains 36.6 acres more or less and is enclosed by a line beginning at corner 1, at or near Lat. 38° 18' 54.5" N., Long. 76° 0' 24.8" W., then running 4° 11' (True), approximately 68 meters to corner 2, at or near Lat. 38° 18' 56.7" N., Long. 76° 0' 24.7" W., then running 6° 50' (True), approximately 177 meters to corner 3, at or near Lat. 38° 19' 2.4" N., Long. 76° 0' 23.9" W., then running 1° 51' (True), approximately 111 meters to corner 4, at or near Lat. 38° 19' 6" N., Long. 76° 0' 23.9" W., then running 90° 0' (True), approximately 623 meters to corner 5, at or near Lat. 38° 19' 6" N., Long. 75° 59' 58.2" W., then running 97° 41' (True), approximately 349 meters to corner 6, at or near Lat. 38° 19' 4.7" N., Long. 75° 59' 43.9" W., then running 159° 14' (True), approximately 160 meters to corner 7, at or near Lat. 38° 18' 59.8" N., Long. 75° 59' 41.6" W., then running 272° 49' (True), approximately 174 meters to corner 8, at or near Lat. 38° 19' 0" N., Long. 75° 59' 48.8" W., then running 309° 57' (True), approximately 294 meters to corner 9, at or near Lat. 38° 19' 6" N., Long. 75° 59' 58.2" W., then running 246° 29' (True), approximately 278 meters to corner 10, at or near Lat. 38° 19' 2.4" N., Long. 76° 0' 8.7" W., then running 235° 49' (True), approximately 128 meters to corner 11, at or near Lat. 38° 19' 0" N., Long. 76° 0' 13" W., then running 234° 52' (True), approximately 131 meters to corner 12, at or near Lat. 38° 18' 57.5" N., Long. 76° 0' 17.4" W., then running 209° 22' (True), approximately 59 meters to corner 13, at or near Lat. 38° 18' 55.8" N., Long. 76° 0' 18.6" W., then running 255° 50' (True), approximately 155 meters to the point of beginning.

The applicants propose to deposit oyster shell and spat-on-shell as needed within the given area to a maximum depth of two inches for the purpose of culturing Eastern Oyster (*Crassostrea virginica*), and to harvest using methods approved by the Department. Lease corners will be marked in accordance with Code of Maryland Regulations. The Department will hold a public informational meeting upon written request from any person whose request also contains their name, mailing address and email address and is received by March 6, 2026. In addition, any person who has a specific right, duty, privilege, or interest that is different from that held by the general public and may be adversely affected by the proposed lease may file a Petition of Protest with the Department protesting the issuance of the lease by March 6, 2026 or within seven days after a public informational meeting held by the Department. A protest filed with the Department must contain all of the following to be considered valid: 1) the name, mailing address and email address of the protestant; 2) a statement indicating that the protestant intends to protest the lease and the reasons for the protest; and 3) a statement describing the protestant's specific right, duty, privilege, or interest that is different from that held by the general public and may be adversely affected by the proposed lease. Petitions that meet the requirements of Natural Resources Article §4-11A-09(g) shall be forwarded to the Office of Administrative Hearings for adjudication. 
