The Secretary of the Department of Natural Resources, pursuant to the Code of Maryland Regulations (COMAR) 08.02.04.11E, announces that two sections of Public Shellfish Fishery Area (PSFA) 69 and one section of PSFA 81 will be closed to all shellfish harvest effective December 4, 2017. The closures were requested by the Queen Anne's County oyster committees to protect planted oyster seed until the sites are suitable for reopening. The closed areas are described below and will be marked by buoys. PSFAs are described in "Public Shellfish Fishery Areas of the Chesapeake Bay and Its Tidal Tributaries (June 2012)", which is incorporated by reference in COMAR 08.02.04.17.

All the waters of the Chester River enclosed by a line beginning at a point defined by Lat. 39°3.964' N, Long. 76°10.754' W, then running 301° True to a point defined by Lat. 39°4.014' N, Long. 76°10.862' W, then running 27° True to a point defined by Lat. 39°4.120' N, Long. 76°10.794' W, then running 116° True to a point defined by Lat. 39°4.070' N, Long. 76°10.660' W, then running 215° True to the point of beginning.

## Piney Point (PSFA 69 (NOB 5-9): Chester River)
