Attorney General's Certification

In accordance with State Government Article, §10-113, Annotated Code of Maryland, the Attorney General certifies that the following changes do not differ substantively from the proposed text. The nature of the changes and the basis for this conclusion are as follows:

Regulation .02B changes that the Secretary may establish a Public-Private Partnership operational unit and/or designate an employee of the Department to administer the Department's Program.

Regulation .04C changes and identifies that the Public-Private Infrastructure Project Committee shall be chaired by a Department employee rather than a Department employee identified by the Secretary and referred to as the Project Committee chair.
