## SMALL BUSINESS COMPLIANCE GUIDE

Amendment to Subtitle 02 Fisheries Service Regarding the Department's Regulations for Oysters COMAR 08.02.04.01 Released May 4, 2020 Updated July 31, 2020

## I. SUMMARY & FAQs

# What was proposed?

The department proposed revising the patent tong line in the Patuxent River. One area, approximately 8 acres, was added to allow for patent tongs.

### Why is this change necessary?

The department received a request to change the patent tong line in the lower third of the Patuxent River to include a small area of oyster bottom. The area being added is currently open to harvest by hand tong and by diving. By changing the line, patent tonging will also be allowed in this small area. The boundary of the sanctuary will not change.

#### Who will this affect?

This action applies to commercial and recreational oyster harvesters.

#### Has this change been discussed with advisory commissions?

This change was brought to the department's attention in 2019 and discussed at the October 2019 Tidal Fish Advisory Commission meeting. It was also discussed at the Oyster Advisory Commission on March 9, 2020. The Calvert and St. Mary's County Oyster Committees have been contacted.


This idea was scoped with the Sport Fisheries Advisory Commission and Tidal Fisheries Advisory Commission at their April 2020 meetings. Commissioners recommended moving forward with scoping.

#### What is the specific regulatory action?

Amend Regulation .01 under COMAR 08.02.04 Oysters.

# **Potential Addition to Patent Tong Area**

The current patent tong harvest area is in gold color. The area being added is circled in red and is located between the shore and Neal Addition Sanctuary (green). The sanctuary boundary will not change.



# II. RECORDKEEPING AND REPORTING REQUIREMENTS

This action does not create new permit, recordkeeping or reporting requirements.

#### III. IMPLEMENTATION DATE

The department expects this change to be effective October 2020, however the exact date cannot be determined. The department will follow our normal scoping and proposal procedures.

During the scoping process, the department gathers suggestions and ideas from stakeholders and others about how to solve a fishery problem or address a need. The goal of scoping is to identify issues, potential impacts, and reasonable alternatives associated with the issues so that management actions can be developed. After the public has had an opportunity to comment on possible management actions during the scoping process, the department considers these comments and develops an appropriate management strategy. The idea for this proposal was scoped from May 4 through May 19, 2020.

At the conclusion of the scoping process, the department determined that the action is necessary and appropriate. The rules are being promulgated following the Administrative Procedures Act described in Title 10, Subtitle 1 of the State Government Article Annotated Code of Maryland.

- The General Assembly's Administrative, Executive, and Legislative Review Committee reviews the regulatory proposal for fiscal and legal analysis.
- The proposal is printed by the Division of State Documents in the Maryland Register.
- A 30 day public comment period begins on the day of publication. The proposed action was printed in the Maryland Register on July 31, 2020. The comment period will close at 11:59 p.m. August 31, 2020.
- After review of the comments, the department may adopt the changes.
- If the department adopts the changes, they become effective after a notice is published in the Maryland Register that announces approval and the effective date.
