2026 Weigh Station – Rules of Operation

1. Closed club tournaments may use the weigh station when available and reserved. You may not weigh-in at the pier/bulkhead or on the water. No weigh-ins are permitted in the parking lot. The weigh station is available April to October.
2. The facility contains:
  - Three (3) 100 gallon tanks that supply circulating and aerated water from Mattawoman Creek. No water treatment is necessary.
  - Three (3) 110 outlets and a table, as well as a drain and measuring board.

**Note: All tournaments must provide their own scales and baskets.**
3. On days of multiple tournaments, take-offs and weigh-ins will be scheduled by Park Staff in advance of the tournament date. Weigh-ins will be scheduled back-to-back in the afternoon. Tournament directors will be responsible for seeing that their tournament stays within the scheduled parameters.
4. Banners and advertising may be hung on weigh station railings. Staples, nails and glue are not permitted when hanging advertising. Some hooks and PVC pipe holders are already provided. All banners and advertisements must be in good taste for public viewing. Park management will remove advertisement deemed inappropriate.
5. All open tournaments may advertise by placing flyers in the tournament box located at the weigh station. **Placing flyers on vehicles at the park is not permitted.**
6. For the health of the Largemouth Bass, all fish must be transported from boats in bags that hold water.

**Please indicate** the location of tents, stages, weigh-in station (if you are not using the weigh-station in the park). Note any other areas you may be utilizing and in what manner you will be utilizing these areas. Completion of this map allows us to ensure that multiple tournaments don't plan to utilize the same space on the same day.

**2026 TOURNAMENT OPERATION GUIDELINES**

The following is a checklist of rules and regulations, which govern the use of Smallwood State Park. Please review each section and sign the form at the bottom. Return this form with your registration form and payment to the above address, Attn: Administration. Maintain a copy of each form for your records.

- ✓ All state parks are trash free. You are responsible for the collection and removal of trash created by your tournament.
- ✓ Pets are allowed in the park. They must be on a leash and be controlled at all times.
- ✓ Parked and standing vehicles are not permitted on Sweden Point Road.
- ✓ The park does not process refunds due to weather, pandemics, or other uncontrollable circumstances, however we will do our best to help reschedule events if given reasonable notice.
- ✓ Vendors and sales of merchandise are not permitted without the authorization of park management. Please apply for any permits at least one (1) week in advance of event.
- ✓ The use of launch ramps and piers is not exclusive to any group or organization unless authorized by park management.
- ✓ The use of amplified music or public address systems is prohibited unless authorized by park management.
- ✓ All park users must abide by the laws and regulations set forth by the State of Maryland governing traffic, operation of vessels, natural resources and criminal activities. Natural Resources Police are law enforcement officers and enforce all Maryland laws.
- ✓ Tournament reservations can be made for the next year starting July 1. Requests must be in writing. Tournament registration is processed on a first-come, first-serve basis. A date is not reserved until we have received your payment and processed your park permit.
- ✓ All tournaments must register their tournament with MD Fisheries Division and have in their possession the permit from Fisheries. To register go to <https://dnr.maryland.gov/fisheries/Pages/bass/ta.aspx> and choose the permit application option. This registration is free.
- ✓ Use of pontoon boat must be scheduled in advance. This includes a release boat permit from DNR Fisheries, 301-888-2423.

Your signature indicates that you have read and understand the rules stated above and the rules of operation for the weigh station included in this packet. It is your organization's responsibility to notify tournament participants of these rules.
