**2022 APPLICATION TO TEMPORARILY TRANSFER A COMMERCIAL
 STRIPED BASS PERMIT OR ALLOCATION-ITQ FISHERY** (Atlantic & Chesapeake Bay)

INSTRUCTIONS AND CONDITIONS:

- 1.) The transferee (person receiving permit) must fill out Section A completely.
- 2.) The transferor (person transferring permit) must fill out Section B completely.
- 3.) The transferor must select: 1.) whether or not a permit is being transferred; and 2.) the percentage of the transferor's annual allocation that will be transferred to the transferee.
- 4.) The transferee and/or transferor will not be required to be present at the Tawes Building Fisheries Office **if** this form is certified by a notary public. Proper identification is needed if submitting this in person at Tawes.
- 5.) Transferors may only transfer pounds to ITQ permit holders. They may transfer an ITQ permit with pounds if the transferee does not hold a commercial striped bass permit.
- 6.) Transferors may make up to four (4) allocation transfers for each year.
- 7.) Commercial striped bass permits, shares, and allocations may not be permanently transferred with this form.
- 8.) Permits and allocations transferred may be used in the Chesapeake Bay only or the Atlantic only. Transferees may use any legal gear within the gear season, as long as the transferee holds the appropriate license.
- 9.) Common Pool permit holders may not receive the transfer of ITQ permits or ITQ pounds.
- 10.) ITQ permit holders may not have Common Pool permits transferred to them.
- 11.) Chesapeake Bay ITQ permit holders may only have 1.5% of the total quota temporarily in a calendar year.
- 12.) A temporary transferee who is convicted or receives an accepted plea of nolo contendere for a violation of federal or State fisheries law that results in a license suspension or revocation may not engage in that fishing activity or receive a **transfer** of a tidal fish license during the period of suspension or revocation.
- 13.) Atlantic ITQ permit holders may only have 10% of the total quota temporarily in a calendar year.
