Inspect your boat and trailer and REMOVE all plant, mud and debris before and after outings to prevent the spread of aquatic hitchhikers

CLEANING CHECKLIST FOR BOATS & EQUIPMENT

Hull & Trailer

- Engine & Propeller
- Anchor & Rope

Drain Live Wells/Ballasts

PFDs, Gear & Equipment

Use high-pressure water, well away from the water's edge, to properly clean and decontaminate your boat and gear.





Drain ALL WATER from your boat, motor, ballasts and live wells on land to prevent the spread of aquatic hitchhikers



Zebra mussel larva and microscopic organisms like spiny water fleas can survive in wet areas for days or weeks, making it essential to drain your boat.

WAIT! DON'T DUMP YOUR BAIT!

Releasing live bait into lakes and rivers is a major source of invasives.



Always dispose of unwanted bait at HOME- NOT in the water!



Allow your boat, trailer and all equipment to DRY COMPLETELY between outings to prevent the spread of aquatic hitchhikers.

AT A MINIMUM, PLEASE ALLOW AT LEAST 48 HOURS FOR BOATS AND GEAR TO DRY

Some organisms can survive in damp areas for days or weeks, making it essential to allow your boat and gear to dry completely. Drying times often vary by season and under changing weather conditions.

Please remember to leave your boat plug out while towing.



The longer you can allow your boat and gear to dry, the better!

A 10% bleach solution may be alternately used to decontaminate gear but should be rinsed thoroughly away from the water's edge.

Why Should You Care?



AQUATIC HITCHHIKERS

are plants or animals that are not native to a water body and have been known to cause significant economic or ecological harm, such as:

- \Rightarrow Loss of biodiversity
- \Rightarrow Altered aquatic food webs
- \Rightarrow Reduced water quality
- \Rightarrow Reduced public safety and health
- \Rightarrow Decline in fisheries and habitat
- \Rightarrow Damage to infrastructure
- \Rightarrow Loss of tourism and recreation

The U.S. spends nearly \$8 billion per year on invasive species control and mitigation.



RECREATIONAL BOATING is a major cause of the spread of invasive species from one water body to the next.
