2. A single delivery at no additional charge will be made early in the season to the following parks and forests throughout the state:
  - Tuckahoe State Park - Queen Anne's County – March 31<sup>st</sup> at 10am
  - Green Ridge State Forest- Allegany County – April 5<sup>th</sup> at 10am
  - Cedarville State Forest - Prince George's County – April 7<sup>th</sup> at 10am

After your order is processed, you will receive a Sales Order - Please bring it with you when you pick up your order. Be sure to count your trees & shrubs at American Native Plants BEFORE you leave the grounds. (Shortages discovered later will NOT be replaced.)
