NEW GRANT PARTNERSHIP WITH MDOT

The Maryland Urban and Community Forest Committee (MUCFC) is excited to announce a new partnership with the Maryland Department of Transportation (MDOT). This new partnership grant is very similar to the existing MUCFC grant with just a change in eligibility requirements and different maximum grant amount.

FRAMING THE FUTURE WEBINAR SERIES

A new webinar series is helping to make state and local forest policy more accessible to natural resources professionals and environmental stakeholders in Maryland. Recurring on the third Thursday of each month at 1 pm, the Framing the Future series launched in November of 2021. The first discussion was on the Tree Solutions Now Act which calls for the planting of five million trees over an eight-year period. The December 2021 session focused on a component of the Tree Solutions Now Act which requires that 10%, or 500,000 of those five million trees be planted in urban and underserved areas.

The Maryland Forest Service, in partnership with the Maryland Forest Conservancy District Boards, is sponsoring a "Poster Contest" for 5th grade classes throughout the State of Maryland.

The theme for the poster is: Trees Are Terrific....and Maryland Forests are Too! Statewide Winners will receive a tree planting at their school.

PEOPLE LOVING AND NURTURING TREES COMMUNITY RECOGNITION AWARD

The PLANT Award is recognition for communities who care for their trees. Communities of all types can receive the award—schools, HOAs, parks, local governments, government facilities, scout troops and churches, just to name a few.

Your Community is probably already at one of the four levels of the PLANT Award program. Choose the level you feel best fits your community's activities in the last year. Over time your community can see your program grow, as your award level increases. The reviewing committee will look at your submitted documentation and then award the best fitting level!

The Maryland Urban and Community Forestry Committee of the Maryland Forestry Boards in partnership with the Maryland Department of Natural Resources sponsor this program and review the applications.

Applications and supporting documentation are due January 31, 2021. Awards will be mailed in mid-March so that you have it in time for Arbor Day celebrations in April!

Communities throughout Maryland are recognized each year, it's time your community joins them! Show off all of your community's hard work taking care of its trees to all who are in it and those that visit!

MUCFC GRANT APPLICATION TIPS

Signature

Every Grant application needs a Forestry Board Member signature prior to submitting.

Find your local forestry board here: www.marylandforestryboards.org then click on local boards at the top of the page.

Funding Plan

Provide an itemized list of how the money will be spent.

Provide a list of species and prices.

If equipment is being requested provide information on who that equipment will be used after the project.

Maintenance Plan

The more detail the better. The committee wants to know exactly how the trees will be taken care of after the initial planting.

Final Report

Submit the final report in order to be eligible for another MUCFC grant in the future.



Pruning


Winter is the best time of year to prune trees. It is easy to see the tree's structure and there is low risk of disease spread. It is



The 3-step pruning method is recommended to reduce the chance of bark ripping and damaging the tree.

Three-step method

- Cut one-third of the way through the branch on the under side.
- Go 2-4 inches beyond the undercut to remove the branch.
- Make the final cut just outside the branch bark ridge and trunk collar.

NEW GRANT PARTNERSHIP WITH MDOT CONTINUED

Eligible projects are those that had trees removed as part of construction of a transportation facility project and are affected by heat island or by environmental justice issues. For the purposes of this grant "transportation facility" is defined as highway construction including bicycle and walking paths.

Those areas affected by the Purple Line construction are also eligible. This grant cannot be used for required mitigation. (All of these construction projects have already complied with one of Maryland's Tree Laws.) Projects can be on public or private land.

The maximum grant award per project is \$5,000. Grant applications are due February 15th and July 15th, as are the existing MUCFC grant applications.

Contact your local forestry board for the application, grant guidelines and assistance in filling out the application.

TREE FAQ

Who should I get to prune my tree?

The State of Maryland requires that any person providing tree care (including pruning and removal) for compensation on trees greater than 20 feet tall must have a Tree Expert License. Always check to see if the person you are hiring has this license. The MD Forest Service website has a searchable list of Licensed Tree Expert (LTE) companies.

Do I need permission to plant and care for a tree?

If the tree is to be planted within a public road right-of-way, you will need a permit from the Department of Natural Resources Forest Service. Check with your local government as some cities and counties have special requirements regarding locating and selecting the right species of trees.
