Introductions:

Dan introduced our landowner host, our consultant guest, and the new urban Forestry Coordinator. Board members introduced themselves.

Minutes Reviewed:

Dan explained that minutes from March had already been approved and sent in for the public record.

Financial Activities, NRCC & Liberty Tree:

Bernie could not attend but provided a report.

Dan talked about the fact that the Vernon Gauss funds were being spent down by Green Ridge, including seed for wildlife food plots, and the rest of the funding will be spent next year, if not sooner.

Dan also reported that all three students for NRCC have been paid for and accepted into camp!

Also, we thanked **Francis** for having the contacts with LaVale Lions Club obtaining another \$500 for NRCC. The balance for Camp Hickory/NRCC after donations and paying for the three students is \$1,020. This means we are set to send 2 more students to camp for 2023.

Francis reviewed two checks for Liberty Tree, and he said to hold the one check and to place the other one in the account. **Francis** will follow up on the one check we received and talk with the person that sent that check.

Big Tree Program:

Dan told the group that we received a thank you from **Joli McCathran** for the donation we made to the Big Tree Program for the Foundation.

Forest Pest Report:

Both **Dan & Ken** received a report from the Maryland Department of Agriculture Forest Pest Management **Susan Winebrenner**. The report showed the Spongy Moth, formerly known as Gypsy Moth, is not a problem for 2021 -2022.

Certificate of Membership:

Dan handed out certificates of memberships for two people **Brad Metzger** and **Sherry Frick**, and has **Marie Miller's** to give to her.

Photo Contest:

Tom and **Sherry** reported that the photo contest will now be open to groups of trees, not just individual trees.

5 Million Trees:

Dan talked about the 13 positions with the DNR FS that are posted and suppose to start in July. There were a few questions about which trees were being counted and **Dan** provided answers.

AES Warrior Run:

AES Warrior Run Electric Generation Power Plant will test fire wood chips and possible conversion to wood chips to replace coal by 2025. **Shannon Farrell** is securing chips for the test firing by working with local loggers.

Carbon Credits:

Steve Resh started things off by saying that ecosystem services are a good thing; that landowners should be made aware of the markets that are out there and this is an extension of our mission! We should consider some type of forum or information sharing event for our landowners.

Tom Mathews suggested that we focus on landowners and people that are not yet engaged in resource management. We need to simplify the message so that we do not overwhelm our landowners and talk about climate change!

Shannon Farrell talked about his experience in trying to help **Darrel Williams** investigate different carbon markets and sharing the values that could be potentially made for the landowner and the challenges associated with that.

Anita Simmons talked about what she was engaged in with the Cumberland City Watershed and the potential of a consultant putting carbon credits out for bid from the City's watershed.

Juls Wood talked about working with landowners and assisting them with selling carbon credit with the Family Forest Carbon Project.

Tom Mathews talked about his experience in trying to help a sportsman's club with the potential of selling carbon credits.

Overall, it was decided after a larger discussion to form a committee to figure out how to get partners on board to help share this message at a possible forum/event with our landowners. The committee will be **Tom, Francis** and **Steve**. They will work on a write-up to present to the Board on June 16 at our next meeting. **Tom** told the committee he will draft out his ideas and share it with the committee so they can have it ready for the Board by June 16.

Tour of Property:

Landowner, **Darrel Williams,** took us on a tour of his property, and we looked at a clear cut, a warbler shelterwood harvest and multiple wildlife food plots. The harvest was completed by a chipping operation and the product went to Kingsford to be sold via a contract the logger had with that company. This tour helped keep the Board grounded while talking about carbon. See the multiple photos.
