Old Business

Review of Minutes:

Minutes were already reviewed electronically and sent into the public record.

Financial Activities:

Bernie provided a copy of the updated financial report and updated that there has been a steady income from liberty tree sales. Donations were received for NRCC from the LaVale Lions Club and Russ Nolan, as well as from Mountain Loggers to support PLT. The only expenses incurred were for

urban tree planting projects and meeting refreshments. The treasurer's report and bank account are balanced with the exception of one small uncashed check.

National Road Tree Cookie to be presented on Arbor Day 2024

Champ provided an update that the Arbor Day event was a success at the LaVale library. A yellow poplar liberty tree was dedicated, and a national road tree cookie was presented and will be displayed near the library entrance. The cookie will be labeled with significant dates with historical relevance. Allegany College assisted in creating these labels.

5th Grade Arbor Day Poster Contest

The top 3 students in Allegany County were recognized with a certificate and a monetary prize. Photos were taken with the top 3 students and posted on our Facebook page. Unfortunately, the Allegany County winner did not make the top 3 in the state of Maryland. Recommendations discussed for next year's contest were as follows.

- Make a video to promote the contest and get this out to teachers by the late winter.
- Have a drop location for posters
- Make copies of posters and consent forms

NRCC

So far 4 students have been interviewed for NRCC and accepted into camp this year. 3 students are from Allegany County and 1 is from Bedford County PA. All have interviewed and should be a good fit for camp.

Website and Facebook Page

Marie updated the board that she had created a new Facebook page and is currently working on a website through Wix, which is a free version. Currently Adam and Marie have administrator privileges, but there was some discussion about adding a third page administrator, as well as page editors, which will ultimately be decided by the digital media subcommittee.

Georges Creek Elementary School Tree Planting Opportunity

Sarah assisted with this planted through the county 4H program. 25 BYB seedlings were planted on private property near Georges Creek. Autumn Simons was the lead point of contact for the 4H.

Bob Webster Memorial Tree

Francis will draft a short saying to honor Bob and will present it at the next meeting. Champ received a reasonable quote from Wanda's Clocks in LaVale.

Forestry Board Summit

Darrel Williams and Steve Resh are enrolled to attend the summit. Juls Wood also has an interest in attending. The board discussed our plan to present 1 liberty tree seedling for every board in the state, as well as 1 for the secretary of DNR and assistant secretary of DNR. Steve volunteered to make this presentation during the summit. Adam will not be able to attend due to a conflict with the MAC fire academy.

Liberty Tree

Champ updated the group that he has sold and shipped more than 10 orders for liberty trees with more to come. All remaining liberty trees have been potted and are being stored and watered at Green Ridge shop. Liberty trees will also be given out at the Forestry Board Summit for each county of the state along with the secretary of DNR and assistant secretary of DNR.

Urban Tree Planting Grants Spring 2024:

Katherine Phillips provided an update saying that all 4 projects were successfully completed this spring. MD Forest Service was involved with and provided technical assistance with these plantings. 105 trees were planted across all 4 projects in total.

New Business

Cumberland Watershed

Steve advised there is a meeting coming up and that they have started a new timber sale, following the forest stewardship plan. Steve will keep the board updated at future meetings.

Envirothon

The forestry component of the Envirothon was successfully administered at the county Envirothon at Rocky Gap state park. Marie purchased 5 field guides to give out to the team with the highest forestry score. This year, every student was given a folder with info on NRCC, forestry 101 camp at Evergreen Heritage Center, and Allegany College forestry program.

Smokey's Reading Challenge

Marie reached out to Rocky Gap State Park, and confirmed that they will partner with us to do a Smokey's Reading Challenge this summer in order to celebrate Smokey's 80th birthday. Marie is working on creating a check list of events and activities that students can complete in order to receive prizes. Small prizes of Smokey Swag (80th birthday stuff) will be given out to all kids who complete the lists. It was suggested to have a Smokey event at Rocky gap in which Smokey himself will be present, and a drawing would be held to give out larger prizes for children of various age groups.

Member Recruitment

The board voted on and approved Sarah as a member of the forestry board. Adam will be sending her an application to be filled out. There was some discussion about adding another member to the board. Slater Hafer will be invited to the next meeting.

Volunteer Hour Reporting

Marie and Adam will be working on creating a Google Forms sheet for the board to track their volunteer hours at forestry board related events. A hard copy hand-written log sheet could also be created as a non-electronic option. All board members will fill out these forms after their participation in events.

Cumberland Tree Initiative Street Tree Inventory

Kat said that the Cumberland shade tree commission is working on a tree initiative in order to track street trees in the city of Cumberland. Marie offered to assist with this by having ACM forestry students complete their GIS projects on street trees in certain sections of the city. It was suggested that the city be broken down into 4 sections and inventoried over a 4-year period. Marie will work with Kat on this project moving forward.
