## BALTIMORE COUNTY FORESTRY BOARD MEETING

July 11, 2023

**ATTENDEES:** Glenn Ferenschak, Richard Anderson, Vic Sanborn (via ZOOM), Julie Wadsworth, Marc Lipnick, Linda Barker and Rob Prenger.

**MINUTES:** Glenn asked members to review the June minutes which they did. Linda brought up the Phoenix Wildlife requirements in order for them to present at the workshop. She asked for a vote to not ask them. Richard made a motion, Julie seconded, all were in favor. No to Phoenix Wildlife as a presenter. Richard made a motion to approve minutes. Marc provided a second. All were in favor. Motion passed.

**TREASURERS REPORT:** Richard provided report. Account #1: \$0000.00. Account #2: \$0.00. Richard wrote a check for \$550.00 to Oregon Ridge for Lodge rental. Not cashed yet, though.

She mentioned the Bay Journal article on this. Need to call Josh Bollinger to see if he will speak on it. Richard said we should have 40-minute presentations. Linda asked about a spotted lanternfly speaker. Richard asked what Kerry was talking about. Glenn said she is doing Woody Plants for Wildlife. Glenn said McDaniel is out. He mentioned topics of Woody Plants..., Soldiers Delight Fire update, Tree Canopy, Native Bees and Protecting Beneficial Birds. Glenn wanted to know what our overall theme was. Vic said, "The Birds and the Bees, the Forest and the Trees." The workshop date is March 16, 2024.

**BIG TREE PROGRAM:** Marc distributed his most recent Big Tree brochure. The chestnut trees at Oregon Ridge were discussed. Linda would like to get a chestnut on the list. Marc mentioned that he and Linda were working on new brochures with new photos. They will cover Cromwell Valley Park, Oregon Ridge, Marshy Point and Lake Roland. MD Park Service is distributing BT brochures at GFSP and PVSP. They will get 100 copies of each for the Parks to see how it goes. Linda will speak to a rep. at Hampton NHS.
