• Seasonal Program Updates - 10 min

- o Tree Baltimore Charlie
 - Tree delivery this week filling nursery.
 - Season giveaway in early november online store & at grow centers (every weekend in Oct) as smaller neighborhood outreach. Another possible in Nov is more leftover
 - Pushing volunteers toward planting that needs assistance
 - Tree keepers this fall has been a success ~50 in sessions. 30 at first in person training. 10 for oct event. Over all 40-45 near certification.
 - Winter gathering unlikely full certifications will probably need to wait till spring
- o Big Tree Fred
 - Baltimore City Big Tree Report for August/September 2021
 - Seven tree nominations were submitted and three remeasurements, 1 new state champion (pending species confirmation) plus 4 other city champions and 2 city co-champions. 3 tree species are new city trees to the state register.
 - Baltimore now has 119 different species (21 different oaks) on the register, 29 of which are state champions or co-champions including 1 national champion.*
 - Thanks to the intrepid tree measuring elves who made this happen; Amanda Cunningham, Ray Iturralde, Sarah Lord, and Patty Dowd, We also assisted with some America Forests nominations in Baltimore County.
 - One of state champions was dethroned, the honeylocust by the Wyman Park Dell. We lost two trees, the shingle oak in Druid Hill Park and the southern red oak near Hill Top House in Clifton.

 - 317 pts
