# **Meeting Minutes**

Gabrielle brought the meeting to order at 6:04 PM.

The October meeting minutes were reviewed and approved by the board via email on 10/23/23.

#### Treasurer's report

- John gave the treasurers report.
- John followed up with Cecil Bank regarding the board's CD account. Cecil Bank increased the board's CD account rate to 5% until June 2024. The CD account will not transferred to another bank.
- The board approved 1 check to be written in the amount of \$272. The check will be used to pay for tree seedlings for Cecil County Schools Arbor Day giveaways, and other board sponsored seedling giveaways in Spring 2024.

## **MBTP Report – October**

For Cecil – Gabrielle visited several churches, graveyards and one school setting to look for big trees that could be included on our Driving Tour South. She identified a half dozen or so and then began obtaining signed permission forms.

John Hudock made several trips thru the property between the Susquehanna River and River Road and has identified a half dozen potential county and State Champions. John B. has asked Jim Sherring for tax maps of the area to determine ownership. Some of that property was donated by Constellation Energy to various State and local governments in 2022.

State – 50 trees were measured or re-measured in October—a new record! 19were new trees and 31were re-measurements. Specifics below: St. Mary's – 3 new – 15 re-measure Wicomico - 7 new – 7 re-measure Howard – 5 new – 5 re-measure Worcester – 2 new – 2 re-measure Charles – 2 new – 2 re-measure

The St. Mary's, Wicomico, Worcester & Charles trees were measured by Joli McCathran and Geary Schwemmer—who reserved camping spots in Worcester and Charles to save money on back-and-forth travel. The Howard trees were measured by Joli and Vince Fillah.

6 trees belong to Historic St, Mary's City and are public access. The new State Champion winged sumac is on Point Lookout State Park property. The continuing State Champion loblolly pine and its twin is found at Milburn Landing Area, Pocomoke City State Park. The State co-champion Atlantic white cedar is the oldest tree (by registry date) from the October list and is found at the City of Salisbury water treatment plant.

In addition to the winged sumac, new State Champions include a privately-owned black oak in Howard County (361 points) and two pond pines owned by the Nature Conservancy in Worcester County. The slightly smaller pond pine at 176 points can be viewed by the public along the Ron Wilson Memorial Trail. The 180point pond pine is not available to the public.

It should be noted that Joli and Geary made several "cold calls" to properties where owners had not responded to phone calls and mailings for permission to re-measure. In some cases they found the trees removed or dead. In some other cases property appeared abandoned. Prior to their visits, we had moved 6 trees in Wicomico and 6 trees in St. Mary's to "Inactive" status as the point value from 2013 suggested the trees would no longer qualify as the minimum score—even considering some point gain.
