Gabrielle brought the meeting to order at 6:05 PM.

The April 2024 meeting minutes were reviewed and approved by the board via email on 4/15/2024.

NRCC Alumni Highlight - Lauren Gilbert

- The Cecil Forestry Board welcomed Lauren Gilbert, a former NRCC camper and camp counselor to the meeting. Laruen is currently employed by the Maryland Department of Agriculture.
- Lauren recounted NRCC experiences and described academic and professional accomplishments since attending NRCC.
- Lauren is exploring options to assist NRCC 2024.

Treasurer's report

- John provided the treasurer's report, and Matt presented it at the meeting.
- No new changes were made to the Board's accounts.

Maryland Big Tree Program Update:

• John provided the report, and Matt presented it at the meeting. John's report is provided below:

MBTP Report –Cecil –Certificates were mailed for all trees measured in March. Three remaining trees to be re-measured in'24. Two at Elk Neck State Park can wait until the fall. Suggest we move to "inactive" the sycamore at Northrop Grumman due to the difficulty in obtaining permission and the restricted access.

In Maryland, **17 trees** were measured; all new trees:

Queen Anne's County – 13 – all at Wye Island Natural Resources Management Area

Baltimore County – 4 – Three at Hemlock Gorge Area of Prettyboy Watershed; 1 at St. Timothy's School

Wye Island NRMA is a tidal recess of the Chesapeake Bay between the Wye River and the Wye East River. Of Wye Island's 2,800 acres, 2,450 are managed by the Maryland Park Service for resource management, recreation and agriculture. A portion of the property is also in the Old Growth Forest Network, Dr. Joan Maloof, Director. Marc Lipnick made two measuring trips there in April—one with Wanda Dade and the second with Linda Barker—both Baltimore County volunteers.

1 new State Champion – a Cherrybark oak at 406 points 4 new QA County Champions – white oak, mockernut hickory, bitternut hickory, lob lolly pine

Marc and Linda measured 3 new trees at Hem lock Gorge. As the name implies, the landscape is very steep and has the best growth of old hem locks in Maryland. Although not independently documented by MD Wildlife and Heritage, Hem lock Gorge also appears to have the largest collection of yellow birch. Six of the 8 registered examples are found in the Gorge; including this new State-co-champion.

1 new State co-Champion at 200 points 1 new Baltimore County Champion mockernut hickory at 235 points

St. Timothy's School is a private girls' school in Stevenson, Baltimore County. It now owns the new Maryland State Champion Kwansan cherry at 202 points. A former employee of the school remembers when it was planted in the 1970's—making it about 50 years old.
