## **Old Business**

Website future – Dawn has contacted the website designer who worked on several of the • forestry board websites throughout the state. The web designer looked over the Calvert FB site and determined that it would be relatively easy to transfer the content to a new server. The designer would only be designing the site and it would be up to the Board to update the content. Dawn will get a cost-estimate of the design fees.

#### **New Business**

- FY22 Ethics filings filings are due from all members by April 30, 2023. At this time, • 1/3 of the Board has completed their filings.
- Green Expo seedlings The Board will be ordering seedlings to give away at the Green • Expo in 2023. Based on the success of potting the trees last year, 50 seedlings will be potted this year. Elderberry and gray dogwood (25 seedlings each) will be ordered.
- ADPC the Board discussed updating the prize amounts to use up part of the budget • surplus. Initially agreeing to double the gift card and prize values, it was not decided if the increase was a one-time only expense or would be made permanent. This issue will be settled by the Board soon. The Board judging night will also be in a new location this year, due to repairs at Battle Creek Nature Center. Alternative locations include Kings Landing Park, Harriet Brown Center and the ACLT offices.

- Envirothon T-shirts The Board will again fund the purchase of t-shirts for the Envirothon. 65 students are estimated to be participating this year. In addition, the Board's long time vendor, Old Town Printing & Graphics has closed and the Board will need to find a new vendor. The shirt design will be rearranged with a large logo on the front and the sponsor's logos on the back. Lavender has been suggested as the shirt colors by the students.
- ACLT seminars Autumn relayed a request from the American Chestnut Land Trust (ACLT) to forward advertisements e-mails for the ACLT's land preservation seminars to the Board's e-mail distribution list. The request was also made to the Forest Service (through Brian). Brian is researching whether the Forest Service can entertain such a request.
