# Minutes of the Garrett County Forest Conservancy District Board Meeting February 14, 2022

#### Call To Order:

The Garrett County Forestry Board met at 9:00 a.m. on Monday February 14, 2022 at Mt. Nebo. Those Board members in attendance either in person or remotely were: Derek Buckel, Bill Aiken, Larry Tichnell, Ken Fisher, Mike Minnick, and Melissa Nash. Also in attendance were Siera Wigfield and John Bambacus. Due to unknown technical difficulties, some members were unable to join the meeting virtually.

# **Mushroom Workshop**

# **Big Tree Fund Request**

Mike M. read a letter from the State Big Tree Committee asking for funds to support the program on the state level. Reasons for the funds having been depleted include mileage & toll reimbursement for those measuring trees, mailing permission forms, website hosting & occasional measuring equipment. Discussion included that Garrett Board members have traditionally measured trees without asking for any reimbursement and we have emailed or mailed permission forms locally so we are not utilizing funds from the committee in that aspect. It was noted that the committee does maintain the database and website which includes our historic records. Mike M. made a motion, seconded by Melissa, to donate \$250. The motion passed.

# **Library Window**

Melissa has scheduled the window display for April. She will find out when we can set up the display at the end of March. Discussion on what to promote included Big Tree, poster contest winners, Arbor Day, LPPRP, Waterwise and Woods in Your Backyard.

Melissa reported that Oakland submitted their receipts for mulch totaling more than their grant amount. She has asked Bill B. for a check to them for their \$180. That will close out that grant.

Sky Valley Association has submitted a new application for tree planting in their common area.

Mike M. shared information on the new MDOT Urban Tree Grant program.

#### **NRCC**

Only 6 students have applied statewide so far. This is well behind where we normally stand with applications. Mike M. will look into promoting the program in schools with Envirothon & FFA.

#### Verso

The Verso company as a whole has been bought out. It is unknown how/if that will affect the status of the Luke property.

## **Tree-Mendous**

Spring orders are now open for trees to be planted on public properties. Tree delivery will be in early April.

## **Mountain Loggers**

No one from the Board was able to attend the last meeting and no report was available.

# **Legislative Updates**

They are asking Forestry Boards to sign on to a letter they have drafted. Ken made a motion, seconded by Mike M. for the Garrett Board to be included. Melissa will let MFA know.
