Minutes of the Garrett County Forest Conservancy District Board Meeting June 2, 2025

Call To Order:

The Garrett County Forestry Board met at 9:00 a.m. on Monday June 2, 2025 at the Garrett County Chamber of Commerce. Those Board members in attendance either in person or virtually were: Linda Harris, Bill Buckel, John Bambacus, Siera Wigfield, Fred Eggleston, Bill Aiken, Will Williams & Melissa Nash.

The agenda was approved following a motion by Fred and 2nd by John.

A motion to dispense with reading of the minutes and was made by Bill B. and 2nd by Bill A.. The motion passed.

The scholarship award was presented to Ariella Malfaro. She briefly highlighted her experience so far in the NRWT program at Garrett College.

Bill Buckel read the treasurer's report. Expenses included supplies for MUCFC plantings, hats and sponsorship of a hole for the Mt Loggers golf tournament, which was approved via e-mail vote prior to the meeting. Melissa advised the remainder of the MUCFC money should be spent soon.

Watershed

Siera advised the county is trying to focus on transparency of projects and keeping everyone informed. She would like to work on some trainings for groups or volunteers to help with trail projects.

Washington Elm

Several folks met to assess the current state of the elm, collect cuttings and measure it for inclusion in the Big Tree Program. It will be the Garrett County champion and will be added to the Big Tree Tour. Melissa advised that some cuttings did not take, but it looks like a few may survive.

Native Plant Festival

We were ablet to reuse some elements from the Library display and gave out approximately 200 tree seedlings. It was a very well attended event. Will reported that Fred Besley's great grandson visited the table.

Smokey Sign

Melissa will ask about possible placement at the Chamber of Commerce/Visitor Center. Some discussion was held on whether we specifically wanted a Smokey sign or a more generic fire danger sign. Further discussion was tabled.

Fire Academy

Melissa gave an overview of the event. They are expecting approximately 220 students plus 50 instructors/staff.
