





RECENT LEGAL DECISIONS AFFECTING AGRICULTURAL LAND CONSERVATION



This presentation will focus on recent court decisions that impact agricultural land conservation. Conservation of working farms can be a mutually beneficial way to preserve rural heritage and open spaces, however, all parties need to understand and appreciate the legal parameters of agricultural land conservation to prevent unexpected consequences. TRYING TIMES: LESSONS TO BE LEARNED FROM FEDERAL TAX CASES INVOLVING CONSERVATION EASEMENT DONATIONS



Since 2005, the courts have issued more than 100 opinions involving challenges to federal charitable income deductions claimed with regard to conservation easement donations. These opinions address a variety of qualification, valuation, and other compliance issues. Professor McLaughlin and IRS attorneys will discuss the lessons to be learned from this growing body of case law, the issues the IRS is focusing on in audits and litigation, and how to minimize the risk of audit and litigation.


