 - Elevate the conversation around pre-service teacher training in environmental literacy & climate education.
 - Leverage the group's diverse stakeholders and expertise to be able to provide needed support and coordinate efforts to ensure all students graduate environmentally and climate literate in Maryland. Ensure resources created do not "sit on a shelf".
 - Deepening connections, broadening understanding of environmental literacy, cognizant of all the work that's going on now and has come before
 - Great opportunity to be bold, build off our environmental literacy foundations; make incremental changes and make advancements just as our predecessors were with ELit standards were created (2007-2009 era).
 - Statewide MD Environmental Literacy and Climate Literacy Plan or the recommendation that one is needed, and budget line items for funding
 - Elevate the conversation around pre-service teacher training in environmental literacy & climate education.
