OLP Updates: Back-mapping the 2025 Annual Report

- Should any working group wish to make recommendations in the 2025 Annual Report to the Governor, OLP has outlined a suggested back-mapping to aid in allowing sufficient time and consideration by OLP and its members. An expanded version of the back-mapping and resources to explore is provided in the OLP WG Co-chair Welcome Packet.

 See below for an abbreviated version:
 - January: explore past recommendations and other resources (past recommendations from PGC, CIN, MCCC in 2023 and 2024, CBP Environmental Literacy Logic and Action Plans, Working Group Background document, etc.)
 - February: discuss goals, barriers, possible actions and recommendations
 - April: research and collect evidence for recommendations
 - June: draft recommendations
 - August: revise recommendations and draft implementation plan
 - September-October: give, receive, and incorporate feedback on recommendations from the full Partnership.
 - November-December: submit final Annual Report with recommendations to OLP and vote on final report.
