brings together educators, students, and community members to discuss this critical issue and empower people to act to mitigate the causes of climate change.

Share-Out: Bridging Environmental Literacy and Career Pathways Workshop

- Workshop hosted by the NOAA Environmental Science Training Center in collaboration with DNR and MSDE, held on Feb 18th.
- The workshop highlighted the opportunities to advance green careers through the implementation of the Blueprint for Maryland's Future Pillar III: College and Career Readiness- by 2031, at least 45% of ALL Maryland high school graduates must complete a [registered youth apprenticeship](#) or earn an [industry-recognized credential \(IRC\)](#).
- Discussion:
 - o Guest speakers at the workshop that shared that an interest in robotics and Legos led them to pursue their studies in oyster population monitoring. What other nontraditional pathways encourage student to pursue green careers?
 - o Travel can be a barrier to participating in some internships and apprenticeships.
 - o [Green jobs as defined globally with references from UNESCO.](#)
 - o MSDE and the [Career & Technical Education Committee](#) of the Governor's Workforce Development Board maintain a state-approved list of Industry-Recognized Credentials (IRCs) that have been vetted and meet standards.
