- MEA provides grants to LEAs to fund new energy projects for Public K-12 Schools:
  - Capacity building for Energy Management, Efficiency, Sustainability, and Portfolio Planning
  - Energy Efficiency and Electrification Capital
  - Solar for Schools
  - Net Zero Schools
- The Decarbonizing Public Schools Grant Program is funded through state funding
- FY26- \$35 Million Applications now open. Closes Nov 21st
  - o Funds are eligible for capital stacking
  - o LEAs can apply for multiple awards in each category
- Solar awards are no longer limited to one per LEA
- Electrifying Community

- Members of the OLP recognize and actively promote the MAEOE Green Schools program as the model to increase the number of Green Schools (Green Schools Act). This recommendation would also to help Maryland to achieve the School District Planning Outcome of the revised Watershed Agreement.
  - o Maryland Sustainable Schools Week?
  - o Dedicate an OLP Whole Partnership meeting to the topic of Sustainable Schools, how do agencies support Sustainable Schools.
  - OLP supports the convening of Facilities Staff around the Green Schools Act
- Timeline:
  - o Sep 11: Present near final version of recommendation to full Partnership
  - o Sep 11-18: Update recommendation to reflect feedback
  - o Sep 18: Share to leadership
  - o Oct: Incorporate leadership feedback
