- o The Chesapeake Bay Program Education Workgroup plans to suggest removing the Sustainable Schools Outcome from the 2014 Chesapeake Watershed Agreement and tracking Sustainable Schools certification as an indicator of the updated Environmental Literacy Planning Outcome
- Tracking the Beyond 2025 Effort at the Chesapeake Bay Program will be a standing agenda item going forward

#### Goals and Priorities as Defined by the OLP Executive Order

- Executive Order 01.01.2024.15
  - OLP Responsibilities name that OLP shall "foster collaboration, coordinate
    resources, and deliver recommendations to decision makers in order to equitably
    ensure that Maryland's Local Education Agencies lessen the environmental
    impact of their school buildings and grounds on their local watersheds (EO
    Section E. 2. d.).
  - This provides the basis for the School Sustainability Working Group description (on <u>OLP's website</u>).
  - o The EO also states that "reducing the impact of Maryland's school buildings and grounds on their local watershed fosters an environmental stewardship ethic among students, builds community resilience, and prepares the State's communities for climate impacts."
  - o Improving school sustainability efforts reduces environmental impacts as well as presenting opportunities for students to "learn about and connect with nature and develop environmental literacy."
- o Prior iterations of the Partnership have addressed School Sustainability by recommending to:



- "Establish a comprehensive initiative to green all schools and school grounds, and embed schoolyard habitat programs as integrated indoor and outdoor instructional components of the curriculum, to create opportunities for outdoor learning experiences for students and members of the community." (2009 CIN Annual Report)
- "Establish a sustainable schools team at the state level to support school districts in developing and implementing sustainability plans." (2018 PGC Reccommendations)
- Suggested back-mapping to structure your meetings for 2025 can be found on page 5
   of 7 of the OLP Working Group Chair Welcome Packet
  - o Recommendations should be drafted by August 29th
- o Potential Sustainable School Working Group actions for 2025
  - A map of who's who in the Sustainable Schools program. What agencies have resources to support sustainable schools' efforts. Perhaps similar to:

  - o Share back to the full OLP
  - Connect with Maryland Commission on Climate Change Education,
     Communication and Outreach Working Group (ECO)
  - External communication
  - Connect with School districts to better understand their needs. Idea: use information from the Green School Applicants to gather that information. Idea: Focus group or survey of schools' sustainability staff



o Develop a toolkit for Sustainable Schools staff at the school-level and the districtlevel. Pair with a recommendation to the Governor's Office to promote that toolkit.
