

## **C&D Canal Lands Non-Hunting Permit 2026:**

Courthouse Point, Elk Forest, Welch Point, Bethel, and Grove Neck MHAs.

**\*Stemmer's Run MHA will be closed to ALL VISITORS until further notice\***

**By accepting this permit you are agreeing to read and abide by all regulations in this packet.**

- Non-Hunting Permits are valid for fishing, bird watching, hiking, and horseback riding.
- All persons who would like to use the C&D Canal Lands for any non-hunting activities must obtain an annual permit, regardless of age. One permit may be used for a single household (Page 2). A separate permit is required for persons interested in hunting or trapping these properties. This permit is not valid for organized group events.
- Non-hunting permits are valid seven days a week, year round, for daytime use only. Be aware and respectful of hunters utilizing these properties. It is unlawful to disturb a legal hunt.
- The Service may suspend or revoke a permit if the permittee fails to comply with the terms and conditions.
- Please report all violations to the Natural Resources Police at 410-260-8888.

**Unless otherwise posted or with a permit issued by the Service it is UNLAWFUL to:**

- Operate or possess a vehicle on roads, trails, or waterways not open to general traffic.
- Bait or feed wildlife.
- Ignite, cause to be ignited, or maintain a fire.
- Camp
- Remove, disturb, damage, or destroy any mineral, plant, rock, tree, or nongame animal.
- Have dogs off leash from April 15 through August 15.
- Release any animal or plant.
- Conduct commercial activities.
- Place a cache for the purpose of geocaching.
- Operate, possess, or use combustibles, explosives, or fireworks.
- Dig for relics and treasures, remove prehistoric or historic artifacts, or use a metal detector without a permit from the Office of Archeology.
- Deposit litter or refuse including, but not limited to, animal carcasses, appliances, brush, debris, furniture, garbage, hazardous material, tires, waste paper, yard waste, or other litter.
- Vandalize real property including any blind, building, crop, equipment, gate, habitat, plant, road, sign, trail, vehicle, vessel, or other public property.
- Graze cattle, goats, horses, sheep, or other domestic animals.
- Target shoot
