## **GENERAL INFORMATION**

This Certification of State of Principal Operation is required when a vessel is not to be used principally in Maryland and is, therefore, exempt from Maryland excise tax. All information on the certification must be provided.

---

§ 8-716 (e) of Maryland's State Boat Act states that a person is not required to pay vessel excise tax resulting from:

(13) The sale of a vessel within the State if:

- i) The vessel is purchased from a licensed dealer;
- ii) The issuance of a title is not sought or required;
- iii) The vessel is not used or to be used principally on the waters of this State;
- iv) The vessel is duly registered in another jurisdiction within 30 days of the date of purchase; and
- v) The dealer and the purchaser execute an agreement certifying the state of principal use for the vessel which is filed with the Department within 30 days of the date of purchase.

§ 8-701 of Maryland's State Boat Act includes the following definitions:

(p) *State of principal use* – “State of principal use” means the jurisdiction on whose waters a vessel is used or to be used most during a calendar year which is the period from January 1 through December 31.

(r) *Use* – “Use” means to operate, navigate, or employ a vessel. A vessel is in use whenever it is upon the water, whether it is moving, anchored, or tied up to any manner of dock or buoy. A vessel is also in use if it is kept in any structure in readiness for use.
