- 1 TRANSCRIPT OF PROCEEDINGS
- 2 CHRIS PARLIN: We will go ahead and
- 3 convene our meeting of the Boat Act Advisory
- 4 April 12 here at 10:00 a.m. Introductions.
- 5 Start with John.
- 6 JON SHELLER: Captain Jon, Deale,
- 7 Maryland. Another day in paradise. We're open
- 8 for business.
- 9 ROBERT NICKEL: Bob Nickel, Western
- 10 Maryland, up in, as I always say, the Great
- 11 White North.
- 12 FRED LEVITAN: Fred Levitan, Timonium.
- 13 CBYC Past Commodore.
- 14 RUSS DWYER: Russ Dwyer, Talbot County.
- 15 AMY CRAIG: Amy Craig, Upper Marlboro,
- 16 Maryland.
- 17 THORNELL JONES: Thornell Jones,
- 18 Annapolis, Maryland.
- 19 JOE HELLNER: Joe Hellner from Anne
- 20 Arundel County, in the Millersville area. Been
- 21 a boater most of my life. All types of



- 1 vessels, power and sail. Also former board
- 2 member, officer and past Commodore of several
- 3 yachting organizations and a former Naval
- 4 officer.
- 5 ROBIN ALLISON: Robin Allison, Galesville,
- 6 Maryland. Power, sail, commercial. You name
- 7 it, if it's on the water, we use it.
- 8 BOB LUNSFORD: Bob Lunsford, Anne Arundel
- 9 County. I'm a trailer boater.
- 10 ROMONA TRAVANO: Romona Travano, Anne
- 11 Arundel County. I'm a waterfront homeowner and
- 12 all kinds of little boats, big boats, whatever
- 13 I can get my hands on.
- 14 STEVE KLING: Steve Kling, Annapolis area.
- 15 I own a sailboat. And I was just thinking, I'm
- 16 trying not to be a former anything.
- 17 JOHN PEPE: John Pepe, Oxford, Maryland.
- 18 Marine surveyor and licensed 200-ton master
- 19 captain.
- 20 DAVE BLAZER: Hi everybody. I've Dave
- 21 Blazer, Director of Fishing and Boating



- 1 Services for the Department of Natural
- 2 Resources. Most of my background is in
- 3 fisheries, however when I did start my career I
- 4 did have a 25 ton captain's license and ran
- 5 some charters early on for the Chesapeake Bay
- 6 Foundation. It's a pleasure to be here. I've
- 7 been on the job for a while and this is my
- 8 first Boat Act Advisory Committee. I'm glad to
- 9 be here and glad to meet you. I already heard
- 10 a couple issues, so I appreciate some of the
- 11 communication we've had already and I look
- 12 forward to the day. Thank you all.
- 13 LOUIS WRIGHT: Louis Wright, hydrographic
- 14 operations, DNR.
- 15 RACHEL EISENHOWER: Rachel Eisenhower, I'm
- 16 with the Attorney General's Office with DNR. I
- 17 haven't been to a meeting for a while, which I
- 18 apologize, but it's good to see everybody
- 19 again. And I don't have any boats.
- 20 JON SHELLER: We can fix that.
- 21 ANN WILLIAMS: Ann Williams, hydrographic



- 1 operations, Fishing and Boating Services.
- 2 JEANNINE MOANEY: Jeannine Moaney, Fishing
- 3 and Boating Services.
- 4 MIKE GRANT: Mike Grant, Fishing and
- 5 Boating Services.
- 6 CHRIS PARLIN: I apologize, I cut you off
- 7 there. And Chris Parlin, chairperson for one
- 8 last day. All right. And -- actually lately
- 9 I've been introducing myself to folks as a
- 10 yacht captain. I used to say retired fire
- 11 fighter, but now I think I've gotten to that
- 12 point where I am a yacht captain.
- 13 JOHN PEPE: I think you qualified.
- 14 CHRIS PARLIN: Thank you. More fun in it
- 15 too. All right. Mike, Manadere Creek.
- 16 MIKE GRANT: As you recall, Manadere is
- 17 still around. We still have some issues
- 18 between the skiers and residents. This year,
- 19 again, the residents convinced Senator Reilly
- 20 and another Anne Arundel County delegate to
- introduce a law to do what you all didn't do,



- 1 or what the community wants to do. Ultimately
- 2 that was pulled. I think greater minds sat
- 3 together and decided that they didn't want to
- 4 go against a legislative directive that they
- 5 had created, letting you guys do your job. So
- 6 that's what happened to that. The ultimate --
- 7 the short story is -- and then another letter
- 8 was written to the Governor, to which Secretary
- 9 Dalton responded we're keeping to our guns,
- 10 however you may consider consulting with the
- 11 Boat Act folks if you and the ski club need to
- 12 come up with some kind of a compromise. It
- won't affect the law specifically, but if you
- 14 can play nice together, perhaps we can find an
- 15 end to this. Well, that's what we tried to
- 16 encourage to happen. And phone calls missed,
- 17 e-mails not returned, et cetera, et cetera. So
- 18 finally Bill Anderson said we're going to
- 19 provide a venue for both groups at our building
- 20 or wherever they want, but at our building, and
- 21 they can hash it out together. Bill and I sat



- 1 there and let them do their thing. It was to
- 2 find compromise. It wasn't a wheeler dealer
- 3 day, it was to find compromise. Three members
- 4 of the ski club and two members of the
- 5 community showed up and it started out with one
- of the members of the community saying, "so
- 7 what do you got to offer." Which kind of set
- 8 the tone. And it dragged on a bit. Bottom
- 9 line is at this point, from what we understand,
- 10 what we can understand, is the community is
- 11 still complaining about a two to three foot
- 12 wake. At the turns, not on the course. The
- 13 noise and the available time for the course.
- 14 Not the amount of time the skiers are actually
- 15 skiing but the time they can ski if they want
- 16 to. They only ski five and a half hours a
- 17 week, period. That's all they can ski. That's
- 18 not only time but they just can't ski that much
- 19 any more. So the community wanted to know when
- 20 specifically, eliminate days, et cetera. And
- 21 the ski club would not accept that. They did



- 1 however say here's some phone numbers, contact
- 2 information and here's access to our web site
- 3 where we schedule our skiing. So that we're
- 4 not running over each other, we know who is
- 5 coming in any given day. No, that didn't work.
- 6 Ultimately the meeting ended after about an
- 7 hour and 15 minutes. And the community left,
- 8 two of the members of the ski club, both
- 9 attorneys, remained and discussed it for
- 10 another hour. According to Bill, Bill was
- 11 still in there in the same room. So that's how
- 12 we ended. That was on the 3rd. This weekend,
- 13 past weekend, Bill and I both were copied on
- 14 e-mails to Senator Reilly and the Secretary and
- 15 attendees of that meeting that basically
- spelled out the community's disappointment with
- 17 the venue, the meeting, nothing was
- 18 accomplished. And then at the very end it said
- 19 we're considering judicial action, which
- 20 basically closed the door on us. We're not
- 21 talking about it any more. It's in Rachel's



- 1 capable hands, or at least the OAG, if it goes
- 2 forward. But we're hoping it doesn't go that
- 3 way. It's just that's the way they want to
- 4 play, that's the way it is. That's where we
- 5 stand right now. Rachel, you want to add
- 6 anything.
- 7 RACHEL EISENHOWER: No, not at this point.
- 8 MIKE GRANT: Anybody have any questions.
- JOHN PEPE: Mike, where does this leave
- 10 the ordinance?
- 11 MIKE GRANT: Everything is fine.
- 12 JOHN PEPE: Everything is staying just as
- 13 it is.
- 14 MIKE GRANT: Yes. The Secretary stands
- 15 behind you all 110 percent. It's legislative
- 16 directive initiative. It's why you guys are
- 17 here. You're doing what you were told to do,
- 18 doing it quite well, and that's the way it's
- 19 going to stay for now. If somebody else wants
- 20 to try to pass a law, then here we go again.
- 21 BOB LUNSFORD: During the meeting with



- 1 community members, were there claims of
- 2 interference with particular activities or
- 3 claims of damage, or just...
- 4 MIKE GRANT: There were inferences that
- 5 "well, my kids came down, my grand kids came
- 6 down to visit and they couldn't paddle board,
- 7 they couldn't kayak. Well, why not. You were
- 8 running in the course. Well, they can paddle
- 9 over there, they can paddle over there, and if
- 10 they want to paddle across the course, we would
- 11 stop at the end of the run and let them go
- 12 across the course." We got people in there
- 13 anchoring out, liner vessels, get up in the
- 14 morning, drank their coffee and watch these
- 15 quys ski. There is -- there was no indication
- 16 and there is no proof from anybody that it
- 17 wasn't going on. So the skiers kept saying,
- 18 we -- they watch us all the time and we don't
- 19 prevent anybody from going in there. Now, when
- 20 we're not there if a boat comes in and gets
- 21 crazy, that's an NRP issue, we have nothing to



- 1 do with that.
- 2 ROBIN ALLISON: Was there any complaints
- 3 to NRP.
- 4 MIKE GRANT: We have not heard of any.
- 5 Given that number -- like generally their
- 6 consensus is they never show up, but when they
- 7 show up, it's too late.
- 8 CHRIS PARLIN: Well, thank you. One of
- 9 the most frustrating things I think I've been
- 10 involved in the whole time, and of course it
- 11 fell under my chairmanship. But I agree with
- 12 you, Mike, I think we did our jobs, we did it
- 13 properly, and it's nice to hear the Secretary
- 14 supports us. That's what we're here for and
- 15 that's why we keep doing what we're doing and
- 16 do the site visits and gather our information
- 17 and do our jobs the best we can. All right.
- 18 Thank you, Mike, appreciate it. Legislative
- 19 wrap-up.
- 20 MIKE GRANT: She is not here yet. Allison
- 21 called and said she had some -- the school is



- 1 having muffins with moms this morning, so she
- 2 got to school and she will be in here as soon
- 3 as she can.
- 4 CHRIS PARLIN: That's fine. Family first.
- 5 Okay. 2017 proposed regulation status.
- 6 MIKE GRANT: I have no official requests.
- 7 I have had a number of inquiries which I'm
- 8 going to present. And I apologize, this new
- 9 projector does not have the hoods that it
- 10 should to generate a good picture in any kind
- 11 of ambient light. I think we can work through
- 12 this. I've added some new graphics that I
- 13 think will help. First of all, South River,
- 14 Edgewater Beach and Cape St. John's.
- 15 Independent. Edgewater Beach is back again.
- 16 It's a different person but same scenario.
- 17 They are complaining about the issues, and here
- 18 we are. Let me jump down. At Marker 17,
- 19 here's Edgewater Beach right here. Here's
- 20 Marker 17. Go back up again. Here's our
- 21 current speed limits here, six knots. Up here



- 1 as we know it's six knots Saturday, Sunday and
- 2 holiday. 35/20 during the day. They have not
- 3 officially submitted anything but he called
- 4 yesterday and promised he had something
- 5 electronically and postmarked by the 15th, so I
- 6 expect to get that one. They have not given me
- 7 a line yet, but he inferred that that's about
- 8 where he wants it, right about there. So that
- 9 he's -- they are not affected by wakes,
- 10 although these people will be now if it's
- 11 there. But they want the six knots run all the
- 12 way up to here now. At the same time, Cape St.
- 13 John, all along here, they want the whole thing
- 14 six knots all time. Currently, and again --
- 15 here we are. This is from Ann's chart. This
- 16 is the current at the bridge, Cape St. John,
- 17 Edgewater Beach, they want this to be six knot
- 18 all the time. If you go back to the minutia,
- 19 to go from the Route 2 bridge to the Riva
- 20 bridge all the way through from here to here at
- 21 six knots, it would be about almost 15 minutes,



- 1 ball park. And these are the various -- I
- 2 didn't print these out because nothing was firm
- 3 yet. Once we get solid information I will get
- 4 them out to you so you can keep them on your
- 5 coffee table. It would be a 15 minute run from
- 6 here to here. I don't know if we're going to
- 7 get this one. When the woman asked for more
- 8 information, I explained the best thing she
- 9 could do was come up with some kind of a
- 10 backup, complaining about damage to property,
- 11 damage to sea walls, erosion, that kind of
- 12 thing. She said -- she called me back and
- 13 said, Mike, I don't think I have any of that,
- 14 I'm not sure this is really worth going after.
- 15 But she is going to have a community meeting.
- 16 And she has got until the 15th to get it in
- 17 here.
- JON SHELLER: We keep coming back to this
- 19 area. Do we know or can we find out what the
- 20 population of boaters is above the bridge.
- 21 MIKE GRANT: I'm sure we could. That



- 1 would be licensing and registration. I guess
- 2 we could get that information. It's a bunch,
- 3 no doubt about it.
- 4 JON SHELLER: Yes, I'm assuming that. But
- 5 that would give us a data point to say this is
- 6 the people you're impacting on a daily basis
- 7 with your proposed regulation, or current
- 8 regulation. And they would -- if I was living
- 9 up there, I would want someone to tell me that
- 10 someone proposes to close the door on my
- 11 boating.
- 12 MIKE GRANT: Well, that will happen if
- 13 this comes to fruition, we'll pop that big
- 14 Humvee in the middle and say notice regulation
- 15 change being proposed with my phone number on
- 16 it, and I'll just transfer the calls to you.
- JON SHELLER: I've got one of those voice
- 18 mails that takes 15 messages and turns off.
- 19 CHRIS PARLIN: John Pepe.
- 20 JOHN PEPE: You also have to keep in mind
- 21 you're affecting a business north of there.



- 1 There is a destination restaurant, several
- 2 businesses up there.
- ROBIN ALLISON: Which is another question,
- 4 have we heard any more complaints from Mike's.
- 5 Mike's was complaining about the wakes also.
- 6 MIKE GRANT: No. Since it didn't go
- 7 through last year, I haven't heard anything
- 8 this year. Because he's aware that it takes
- 9 three years for you guys to look at it again.
- 10 ROBERT NICKEL: But they would have input
- 11 on this.
- 12 MIKE GRANT: Oh, of course they would.
- 13 And, again, I apologize for this, but this
- is -- there's the distance from the Cape St.
- 15 John, about 980 feet. About 230 feet out to 17
- 16 from Edgewater Beach. And I wish this would
- 17 look better, here's a close-up again. Here's
- 18 the docks. And those of you that have been
- 19 here, you realize this is just about at sea
- 20 level. In fact their stone bulkhead is above
- 21 the land and the land is actually at sea level.



- 1 So there is an issue there. This is the one I
- 2 wanted to show you. This is April 1994. It
- 3 looks pretty much the same if -- as it dose
- 4 2017. There is very little evidence of any
- 5 kind of erosion. Again, got to get a better
- 6 projector here. So any more questions on this
- 7 one. Blow through this. This is Tred Avon,
- 8 Dixon Creek, Maxmore Creek. Again, these were
- 9 inquiries over the winter. Here's Easton.
- 10 There is a little marina up here. John, what's
- 11 the name of it.
- 12 JOHN PEPE: Easton Point.
- 13 MIKE GRANT: Easton Point Marina. Dixon
- 14 Creek is up in here, Maxmore Creek down here by
- 15 Royal Oak. From the marina to Dixon is about
- 16 1.2 nautical miles and down to Maxmore is about
- 17 three nautical miles. This gentleman was not
- 18 clear, he just wanted something done and he
- 19 never got back to me. I think he was looking
- 20 for six knots. Here's Dixon. It's a decent
- 21 amount of water. I think he was mostly



- 1 complaining about jet skis, but again he hasn't
- 2 gotten back to me. Maxmore was more specific.
- 3 This gentleman has a lovely little estate right
- 4 here and he's complaining about boaters zipping
- 5 by. 700 feet, 500 feet. It's about a half
- 6 nautical mile to the entrance. It's a lot of
- 7 room to operate up in there but he wanted this
- 8 area shut down to six knots all time. Again, I
- 9 have not heard back from him.
- JOHN PEPE: A lot of new development north
- 11 of that area, between Easton Point and Maxmore.
- 12 MIKE GRANT: Okay. So that has not come
- 13 through. Here's where he is. And the Tred
- 14 Avon down here. Any questions on this one.
- 15 Easton Bay Greenwood. And I should have pulled
- 16 this one because a friend I know through the
- 17 yacht club over on Kent Island approached me
- 18 about this and I explained that this gentleman
- 19 right here, again, this is about 425 feet wide,
- 20 about a nautical mile to the bay, it's
- 21 chokepoint here but it's not that much at four



- 1 and a quarter. He wants it shut down just
- 2 right here. And the gentleman who I spoke with
- 3 lives up in here and he went up and down here
- 4 and talked to everybody and nobody wants it.
- 5 BOB LUNSFORD: Community support, we like
- 6 that.
- 7 MIKE GRANT: For us. Or for you.
- 8 JOHN PEPE: Great waterskiing creek too.
- 9 MIKE GRANT: I bet. That's a picture
- 10 right there. Wye Narrows up in here, Wye
- 11 River.
- 12 STEVE KLING: I'm noticing a pattern that
- 13 these water skiers are getting us in trouble
- 14 all the time.
- 15 MIKE GRANT: Plus they're competitive.
- 16 AMY CRAIG: I narrowed them down to three
- 17 spots. Keep the trouble contained.
- 18 MIKE GRANT: So Greenwood I think we're
- 19 not going to hear anything from. Ocean City,
- 20 Isle of Wight. This is a questionable one.
- 21 This just came in last week. Isle of Wight is



- 1 up here at this point of land that comes out
- 2 right here. It has the Jolly Roger amusement
- 3 area. And this end right here, as you can see,
- 4 kind of barely. Of course all the channels are
- 5 six knots in here. The channel is very skinny
- 6 through here. All these vessels are on lifts.
- 7 And there is your distance from the green all
- 8 the way up to the shoreline. This is the area
- 9 they want to go to six knots. And this down
- 10 here is all six. Here's the area again.
- 11 Here's the current channel. As you recall, you
- 12 made a change to this a couple years ago,
- included this in the six knots. Once you get
- out of here, you're freewheeling all the way up
- 15 to Delaware. They want this going to six
- 16 knots, which would mean, you know, wide open,
- 17 six knots, wide open, and then six knots all
- 18 the way to the ocean. There it is again, the
- 19 marks.
- 20 BOB LUNSFORD: Mike, did that come in as a
- 21 petition or just a request.



- 1 MIKE GRANT: Came in as a call and
- 2 discussed it with him, and I said you've got
- 3 until the 15th. And he said he would try to
- 4 get something in and postmarked by the 15th.
- 5 ROBIN ALLISON: What was the issue?
- 6 MIKE GRANT: They are getting too much
- 7 wakes. That people swimming in there are
- 8 getting rocked. The boats are getting rocked.
- 9 Bulkheads are getting rocked. It's
- 10 uncomfortable.
- 11 ROBIN ALLISON: And everybody is on a
- 12 lift.
- 13 MIKE GRANT: Yeah, pretty much. Or on a
- 14 float.
- 15 ROBIN ALLISON: Very curious.
- 16 ROBERT NICKEL: And the prevailing wind is
- 17 from the west, so that's a lee shore where you
- 18 always have waves because it's always blowing
- 19 in Ocean City. So the boats are probably
- 20 tamping down the...
- 21 RUSS DWYER: If anybody has been there,



- 1 you're just trying to get to that bridge before
- 2 it closes too.
- 3 MIKE GRANT: That's true too. I have a
- 4 feeling that this might be fought pretty hard.
- 5 CHRIS PARLIN: And everybody just
- 6 remember, we've got a stenographer trying to
- 7 keep up with us, so one at a time.
- 8 MIKE GRANT: Here it is again. And some
- 9 charts again. This area all along here, it's
- 10 all regulated now at six knots. Here's the
- 11 area that you all put in a couple years ago.
- 12 Six knots all time. So this is the canal right
- 13 here right out. That's all I have.
- ROBIN ALLISON: So are any of these
- 15 petitions yet?
- 16 MIKE GRANT: No.
- 17 ROBIN ALLISON: Just phone calls.
- 18 MIKE GRANT: I expect to get the Edgewater
- 19 Beach and possibly this one, the Ocean City.
- 20 BOB LUNSFORD: Can I get season pass for
- 21 Oak Grove Marina, Mike.



- 1 CHRIS PARLIN: Mike, you jumped ahead to
- 2 the 2018 regulation request. 2017 proposed
- 3 regulation status.
- 4 MIKE GRANT: I'm sorry. The only thing we
- 5 had was the data point on Yans Creek on the
- 6 Severn River. We had -- we lost the land to
- 7 the southwestern tip of the ski zone and had to
- 8 move it to a new point of land. Louis and Ann
- 9 figured that out and that went through no
- 10 problem. That's all we had, right. It went
- into effect March something. That's it.
- 12 CHRIS PARLIN: Thank you, Louis.
- 13 Legislative session wrap-up. Allison.
- 14 Welcome.
- 15 ALLISON CORDELL: Good morning. Good to
- 16 see you all again. Allison Cordell, the
- 17 legislative director for the Department of
- 18 Natural Resources here to give you a guick
- 19 update on legislative session that wrapped up
- 20 on Monday at midnight. So it was a long, long
- 21 Monday and still recovering from the lack of



- 1 sleep. But it was a good session for us. So I
- 2 wanted to talk to you about the new -- the
- 3 bills that have passed that are likely to be
- 4 signed by the Governor. They are not new laws
- 5 yet but we expect they will all become -- I
- 6 don't anticipate that any will be vetoed. We
- 7 had four departmentals. This was for our
- 8 recreational discount promotion program to
- 9 continue. So we're allowed to give a discount
- 10 for our fishing and our hunting licenses. We
- 11 also repealed two of our defunct commissions.
- 12 So if you look at our commission list, it is
- 13 getting cleaned up so that the ones that are
- 14 active are going to be listed and the ones that
- 15 are not have been repealed from our article.
- 16 We also clarified that pigeons are still
- 17 unprotected in the State of Maryland. And that
- 18 on our tidal fish license you can designate a
- 19 beneficiary at any time and that the cancer
- 20 crab would be added to the, conch, turtle,
- 21 lobster permit license. So those were our four



- 1 departmentals, but the one that would really
- 2 have to you with you is MDE's departmental.
- 3 This was SV 100, reservoir, dam or waterway
- 4 obstruction plans, designation of approval.
- 5 This just helps streamline the process with MDE
- 6 for those removals. Now, really on to the
- 7 waterway related ones. We had Senate Bill 115,
- 8 Deep Creek Lake Policy and Review Board.
- 9 Department of the Environment was added to the
- 10 list. Pretty simple. On our licenses, when
- 11 you go to purchase a license through DNR,
- 12 through our compass page, you will be able
- 13 to -- you will be able to give a voluntary
- 14 donation, both to the Chesapeake Bay Trust, the
- 15 2010 Trust Fund, as well as if you want to
- 16 designate funds to our veterans. We would be
- 17 able to give a discount to our veterans through
- 18 that voluntary donation. Senate Bill 501 was
- on the State lakes protection plan. This
- 20 requires an appropriation of a million dollars
- 21 to the State lakes fund. We have 16 State



- 1 lakes, and I'm sure that there will be a
- 2 competitive award process on who receives the
- 3 funding from that million dollars. There also
- 4 was Senate Bill 1260 Waterway Improvement Fund,
- 5 Ocean City dredging study. This requires
- 6 300,000 from the Waterway Improvement Fund for
- 7 this purpose. The department had looked at
- 8 what was available in the Waterway Improvement
- 9 Fund, had offered the Town of Ocean City
- 10 200,000 as our portion of the match. However,
- 11 they decided to go another round from what we
- 12 were offering through the legislature, and we
- 13 are now to designate 300,000 for this purpose.
- 14 House Bill 917, this was a local bill on
- 15 Frederick County Scenic River Advisory Board
- 16 changing their membership. And House Bill
- 17 1845. This was those for those that have
- 18 aquaculture off of their piers. They would be
- 19 able to harvest not just from 5 feet but up to
- 20 10 feet. There is a restriction but this is
- 21 for noncommercial purposes. What failed might



- 1 be of most interest to you. We had the State
- 2 Boat Act, which was on carbon monoxide. This
- 3 was House Bill 795. And there was also House
- 4 Bill 803, the boat winterization shrink wrap.
- 5 This was -- unfortunately a gentleman named
- 6 Matthew passed away after removing the shrink
- 7 wrap from his vessel, and so they wanted to
- 8 require additional notice from the department
- 9 and from those that were providing the shrink
- 10 wrap on the harms of carbon monoxide poisoning.
- 11 We talked to them about how we do have this
- 12 information included in our boating safety
- 13 course and we do have that information printed
- 14 in the brochure. So it is available for all of
- 15 our boaters, and so this ultimately did not
- 16 pass. Madamere Creek ski zones. This was also
- 17 put up again. This year it did not make it
- 18 through. This was House Bill 299 and Senate
- 19 Bill 141.
- 20 CHRIS PARLIN: Finish up and we'll come
- 21 back.



- 1 ALLISON CORDELL: So that would be on
- 2 Madamere Creek. We had an interesting bill
- 3 come up by Delegate Metzgar on solar reflective
- 4 lights on our buoys. This would require all
- 5 buoys in state waters to have solar reflective
- 6 lights. This had a very high fiscal cost and
- 7 we were concerned about really lighting up the
- 8 bay, not only how it could confuse boaters but
- 9 also what it would do for our wildlife. So
- 10 this did not pass but Delegate Metzgar does
- 11 want to follow us with up about some concerns
- 12 he has about visibility for the buoys. A
- 13 question that might come to you. We also --
- 14 there was criminal negligence, manslaughter or
- 15 homicide by vehicle or vessel. This did not
- 16 pass. House Bill 325. And House Bill 406,
- 17 life threatening injury by vehicle or vessel.
- 18 This would increase the penalties. Neither of
- 19 those made it through. House Bill 820, this
- 20 was put up by Delegate Mautz. To exempt both
- 21 the purchase -- the purchase of boat motors



- 1 from sales and use tax. And the final one that
- 2 also did not pass but is boating related would
- 3 be the creation of a state debt, House Bill
- 4 654, Annapolis Maritime Museum and Park. No
- 5 funding was given to them. And that is all.
- 6 Any questions.
- 7 JOE HELLNER: I have a question on the CO2
- 8 bill. It looked like it got through the Senate
- 9 after a bunch of amendments. If I recall
- 10 correctly it was widdled down to a brochure
- 11 that the DNR would provide.
- 12 ALLISON CORDELL: It was.
- JOE HELLNER: Do you see that coming back
- 14 perhaps next year since it made it all the way
- 15 through the Senate. Did there -- I know the
- 16 sad case of Matthew passing away kind of drove
- 17 this.
- 18 ALLISON CORDELL: It did. And there was
- 19 very compelling testimony that was provided.
- 20 The house subcommittee on environment and
- 21 transportation really, you know, felt for the



- 1 family, did not want to give an unfavorable
- 2 report. So instead of ever publishing that it
- 3 was an unfavorable, they held that one and it
- 4 just didn't cross the finish line instead of
- 5 receiving that unfavorable from the committee.
- 6 While I think they feel for the family, they
- 7 see that this was one incident. It's not
- 8 something that we have a substantial need for
- 9 more education to our boating community on this
- 10 issue.
- 11 JOE HELLNER: Your early read on it is the
- 12 legislature probably won't bring the carbon
- 13 monoxide or the shrink wrap back next year.
- 14 ALLISON CORDELL: This was two years in a
- 15 row, so I don't believe they will try for a
- 16 third. But new membership next year, you know,
- maybe.
- 18 CHRIS PARLIN: Any other questions.
- 19 ALLISON CORDELL: Thank you.
- 20 CHRIS PARLIN: Thank you, Allison. We're
- 21 going to push forward. Old business. Does



- 1 anybody have any old business they would like
- 2 to talk about. Okay. Hearing none. New
- 3 business. Steve Kling. I'm sorry.
- 4 DAVE BLAZER: If I can, I just want to
- 5 make the committee aware, and Allison may help
- 6 me out here a little bit, the Governor signed
- 7 an executive order a couple months ago about
- 8 the Maryland Outdoor Recreation and Economics
- 9 Initiative. And we, the Department and the
- 10 Department of Tourism, are putting together an
- 11 advisory group that is supposed to meet soon.
- 12 I don't think they have met yet.
- 13 ALLISON CORDELL: May 18th is the date I
- 14 have in my mind.
- DAVE BLAZER: But they are going to look
- 16 at how can the State help with outdoor
- 17 recreation experiences, both from a business
- 18 viewpoint and also the consumer and the people
- 19 getting out. In Fisheries, we're pretty active
- 20 in it and they are looking at parks and
- 21 wildlife, but boating is obviously a part of



- 1 the outdoor experience as well. So I wanted
- 2 you all to be aware of that, that that's just
- 3 kind of kicking off. I'll make sure, Mike, if
- 4 we can get a copy of the executive order, we
- 5 will send that to you just so you're aware of
- 6 what that group is doing and make you aware of
- 7 other meetings and then efforts to look at some
- 8 of the boating outdoor experience that we have
- 9 in Maryland. So just wanted to bring that to
- 10 your attention.
- 11 ALLISON CORDELL: One of the things the
- 12 Commission is going to be looking at is how to
- 13 really brand and market our State for our rec
- 14 opportunities. So boating is a huge component
- of that. All of the waterways that we have to
- offer to the recreational community is going to
- 17 be of course a needed aspect of this
- 18 conversation.
- JOHN PEPE: Will this possibly get some
- 20 grant funding or sustainable waterways or
- 21 working waterfront community type.



- 1 DAVE BLAZER: I think that's a
- 2 possibility. You know, obviously you put a lot
- 3 of the advisory groups together that are going
- 4 to put recommendations, and their hope is to
- 5 put recommendations together. Funding is
- 6 always one of those. Bunch of great ideas but
- 7 how do you pay for them. So I'm sure that will
- 8 be some of the discussion that they will have.
- 9 ROMONA TRAVANO: What's the membership on
- 10 the group.
- 11 DAVE BLAZER: It's statewide. I think
- 12 they have got an Ocean City rep, a Deep Creek
- 13 person and a bunch of people in between.
- 14 ROBERT NICKEL: And from what walks of
- 15 life or experiences.
- 16 DAVE BLAZER: Well, I know there is a
- 17 couple fishing folks. But it's a 16 --
- 18 ALLISON CORDELL: There is some from
- 19 industry as well. I want to say from Under
- 20 Armor or REI there is a representative. And
- 21 the membership, I think at least around 30.



- 1 DAVE BLAZER: It's a pretty large group.
- 2 ROMONA TRAVANO: And the objective of the
- 3 executive order is to promote recreational
- 4 tourism.
- 5 DAVE BLAZER: Yeah, outdoor recreation and
- 6 tourism. Again, we'll make sure we send that
- 7 executive order and the membership.
- 8 CHRIS PARLIN: Thank you.
- 9 JOE HELLNER: On that topic, since you
- 10 mentioned there is interest in boater feedback,
- 11 how would boaters be able to get back to the
- 12 committee and provide comments or suggestions.
- DAVE BLAZER: Well, they haven't met yet,
- 14 so I think setting up -- I know they plan to
- 15 have meetings across the state. They are not
- 16 just going to be housed here in Annapolis, they
- 17 are going out to Deep Creek and Ocean City and
- 18 a lot of places in between and heavily
- 19 advertise those. I think as they go we'll make
- 20 sure that we advertise those things and use our
- 21 advisory committees to try and get information



- 1 about what's going on and let you be aware of
- 2 that. I know on the fishing side, our Sport
- 3 Fish Advisory Committee, you know, this is
- 4 something obviously that they are very
- 5 interested in as well.
- 6 JOE HELLNER: And would consideration be
- 7 given to posting that on the DNR web site so
- 8 that we can -- if, for example, I get questions
- 9 about this, I can point people in the right
- 10 direction as to how they might engage with the
- 11 group.
- DAVE BLAZER: Absolutely, that will all be
- 13 set up.
- 14 CHRIS PARLIN: Thornell.
- 15 THORNELL JONES: Is this in any way
- 16 related to the National Park Service trying to
- 17 get more people on the water.
- 18 DAVE BLAZER: I'm not sure where the
- 19 initiative came from. I know REI was
- 20 interested in doing it. So I don't know all
- 21 the details of how it got legs originally.



- 1 ALLISON CORDELL: There is a national push
- 2 for this, for more information and marketing of
- 3 our outdoor recreational opportunities. So
- 4 there was a National Governor's Association
- 5 meeting a couple, maybe a month ago, that many
- 6 members from different states that are engaged
- 7 in this activity met together and we had
- 8 national park representatives there as well.
- 9 CHRIS PARLIN: Okay. Thank you. Any more
- 10 questions. We had another guest walk in.
- 11 BILL ANDERSON: How are you.
- 12 CHRIS PARLIN: Good.
- 13 MIKE GRANT: Assistant Secretary Bill
- 14 Anderson.
- 15 CHRIS PARLIN: Give the opportunity for
- 16 somebody to introduce him. Welcome. All
- 17 right. Still under new bills. Steve Kling,
- 18 you have some housekeeping to do here.
- 19 STEVE KLING: Yes. Nominating committee.
- 20 It's time for -- our two years is up, your two
- 21 years is up.



- 1 CHRIS PARLIN: Which it was at the end of
- 2 the year this past year but we didn't meet in
- 3 the winter so here I am.
- 4 STEVE KLING: And the nominating committee
- 5 comprises of Mr. Lunsford and myself to discuss
- 6 things, and we would recommend to the committee
- 7 for a two year term, to end at the end of the
- 8 calendar year 2019, Amy Craig as Chair,
- 9 Thornell Jones as Vice Chair, and Jon Sheller
- 10 as Officer at Large.
- 11 ROMONA TRAVANO: Second.
- 12 STEVE KLING: You don't need a motion,
- 13 second, when it's a committee.
- 14 ROMONA TRAVANO: Sorry.
- 15 CHRIS PARLIN: Just a vote on it. And any
- 16 questions.
- 17 RUSS DWYER: You heard from the attorney
- 18 too.
- 19 CHRIS PARLIN: Vote to approve.
- 20 BOB LUNSFORD: Wait a minute. Do you want
- 21 to veto this motion. This is your last chance.



- JON SHELLER: No, that's fine.
- 2 CHRIS PARLIN: Everybody in favor.
- 3 Anybody opposed. Okay. There's your new
- 4 membership. Happy birthday to me.
- 5 ROMONA TRAVANO: Chris, thanks for doing a
- 6 great job.
- 7 CHRIS PARLIN: Thank you. Appreciate it.
- 8 Like I said, I think Manadere was our toughest
- 9 meeting and it was a long meeting, but I think
- 10 in the long run it really matters that we took
- 11 that time to listen to everybody, give
- 12 everybody their chance to speak. And I think
- 13 we truly did a good job on that one. Even
- 14 though it keeps coming back, we have triumphed
- 15 through so far. Okay. I guess with that,
- 16 anything else, any other new business.
- 17 BOB LUNSFORD: Chris, you have to give
- 18 your personal reflections over lunch.
- 19 CHRIS PARLIN: That's right.
- 20 ROMONA TRAVANO: This isn't new business.
- 21 But the web site that has all the regulations,



- 1 boating regulations, I continue, just random
- 2 people, friends of mine, say what a wonderful
- 3 site that is and how much they really enjoy it.
- 4 A friend of mine who is active in the Coast
- 5 Guard Auxiliary and they are interested in the
- 6 site as well. I just wanted to say job well
- 7 done, folks.
- 8 CHRIS PARLIN: And that's something I kind
- 9 of started years ago when I first got on the
- 10 committee and said, hey, we've got a younger
- 11 generation that's tech minded and everything is
- 12 online. And Louis and Ann put in so much work
- on that and I'm sure there is a few others in
- 14 the background that did the web site
- 15 development and what not. Yes, thank you both
- 16 of you, and anybody else who was involved. It
- 17 really is a good product.
- 18 ROMONA TRAVANO: I don't know if you're
- 19 getting that feedback directly, but I hear it
- 20 all the time.
- 21 ANN WILLIAMS: We don't get all the good



- 1 stuff. We get the Manadere phone calls.
- 2 CHRIS PARLIN: Job well done, seriously.
- 3 Thank you for bringing that up, Romona. Very
- 4 good. Any other new business.
- 5 JOE HELLNER: I would also like to add,
- 6 following Romona's theme, for the record as
- 7 well, I've been a user of the DNR web site for
- 8 a long time and I just want to say the whole
- 9 DNR web site gets better it seems every year.
- 10 It's more user friendly than ever, more
- 11 intuitive, I'm able to get quickly to the
- 12 things I want to see on the DNR web site. I
- 13 wanted to give that positive feedback back to
- 14 the DNR as well. It gets better every year.
- 15 Thank you.
- 16 CHRIS PARLIN: Okay. Did you have any
- 17 words you want to share.
- 18 BILL ANDERSON: No, seems like a bit of a
- 19 light agenda this year. Again, I just want to
- 20 thank you guys for your commitment to being a
- 21 part of the committee. These things are tough,



- 1 and you mentioned Manadere, but they are tough
- 2 in general and it takes away from your
- 3 business, your family, so I want to thank again
- 4 everybody on the team. And our DNR support
- 5 team for everything you guys do for the boating
- 6 public.
- 7 CHRIS PARLIN: Thank you. All right.
- 8 Motion to adjourn.
- 9 BOB LUNSFORD: Can we hang around for
- 10 lunch. That's a lot of food to save.
- 11 CHRIS PARLIN: We can have some off the
- 12 record discussions after adjourning.
- BOB LUNSFORD: I'll make a motion we
- 14 adjourn.
- 15 JOE HELLNER: Second.
- 16 CHRIS PARLIN: All in favor.
- 17 COMMITTEE: Aye.
- 18 CHRIS PARLIN: We're adjourned.
- 19 (Meeting concluded at 10:43 a.m.)
