## Welcome/Meeting Objectives

DNR Secretary Mark Belton called the meeting to order and welcomed Council members. DNR Staff Zoe Johnson gave a recap of the May 28, 2015 CS Council meeting. Most of today's meeting will be dedicated to reviewing and finalizing the Draft Coast Smart Construction Program Document.

The first order of business was the approval of the Coast Smart Council May 28, 2015 meeting minutes. Minutes were approved with no changes.

## **Presentation of Draft Coast Smart Construction Program Document (6.10.15)**

Zoe Johnson presented the Coast Smart Construction Program Document with changes that she integrated. The Council went through the document page by page:

- Page 2: July 15 was changed to July 1 due to statutory requirements.
- Page 3: There was a question about a possible definition of substantial damage for repetitive losses. Zoe responded that the Council has used the definition from FEMA. One possible solution is to create a reporting mechanism to track the repairs that were done cumulatively over the years, or defer to the agency.
- Page 4: no opposition to changes made
- Page 5: no opposition to changes made
- Page 6: There was a question about if a project is an exception, does the project still have to have some level of resiliency. Zoe responded that there are still requirements through the project screening checklist.
- Page 7: "2016" was added after October 1, and "...made in the past fiscal year" was added after the Annual Reporting to Council paragraph.
- Page 8: no opposition to changes made
- Appendix A: Definitions no comments
- Appendix B: Screening Checklist no comments
- Appendix C: Exceptions Cover Sheet no comments
- Appendix D: Waiver Cover Sheet need to strike historic preservation category because it was moved up to Exceptions; "Other" category also needs a line that is able to be filled in

#### Discussion:

- Coast Smart principals should infer that agencies will consider repetitive losses and incorporate coast smart guidance into these repetitive repairs
- There was concern about whether there is guidance in place to determine what NNBFs would protect structures from sea level rise, storm surge, or coastal flooding. Zoe responded that DNR is working on a comprehensive list to rank NNBFs.

The Coast Smart Construction Document was approved with the changes made today, with no dissent.
