

**Elk Neck State Park  
Rogues Harbor Boating Area  
Tournament Operations Guidelines**

All State Parks are **trash free**. You are responsible for the collection and removal of all trash created by your tournament.

Pets are allowed in Rogues Harbor to board vessels only and must be kept leashed at all times.

Parked and standing vehicles are not permitted on the exit lane and grass area near the launch ramps.

Vendors and sales of merchandise are not permitted without prior authorization.

The use of launch ramps and piers is not exclusive to any group or organization.

The use of amplified music or public address system is prohibited unless authorized.

The service charge for launching is \$10.00 per Maryland registered vehicle.  
\$12.00 per Out-of-State registered vehicle.

All park users must abide by the laws and regulations of the State of Maryland governing traffic, operation of vessels, Natural Resources, and criminal activities.

Tournament reservations can be made up to one year in advance. The request must be in writing.

Your signature indicates that you have read and understand the rules stated above and agree to abide by them. It is your organization's responsibility to notify tournament participants of these rules.

Tournaments with 10 boats or less are not subject to the service charge.

2. A schedule of events.
3. A sketch map of the location of tents, weigh in area, stage, etc., if planned.
4. A copy of any promotional flyers.

**BLACK BASS REGULATIONS:**

Black Bass tournament directors must obtain a free permit if they:

- Have at least 10 boats or less participating
- Offer a reward for catching bass.
- Have a staged weigh-in area.
