Applications received after that date will be returned and retesting will be required in order to be licensed. Incomplete or unsigned applications will not be processed and will be returned to the applicant for resubmission. NEW: An email address is required. If it is not in our database, you will not be able to use the online continuing education credit log-in as it is one of the passwords.
