Minutes of the Garrett County Forest Conservancy District Board Meeting (Virtual Meeting) April 12, 2021

Call To Order:

Each board has been asked to cast one vote for the candidate of their choice. Melissa made a motion, 2nd by Ken to cast our vote for Mike. The motion passed.
